1. CALL TO ORDER/ PLEDGE OF ALLEGIANCE

Chair Hart called the meeting to order at 7:05. Committee Member Donchak led the Pledge of Allegiance.

3. MINUTES

A. Minutes of the April 13, 2006, Regular Meeting

IT WAS MOVED BY COMMITTEE MEMBER BURROR, SECONDED BY COMMITTEE MEMBER DONCHAK AND UNANIMOUSLY CARRIED to receive and file the minutes of the April 13, 2006, meeting as presented.

4. PUBLIC INPUT - None

5. OLD BUSINESS

A. <u>Vital Few Priorities – Rankings and Follow-up</u>

John Beck, Senior Park Planner, briefly reviewed the priority rankings list approved by the City Council. He noted the Beach Signage Master Program would come back to this Committee for their review and comment before implementation. Staff recommended the Committee receive and file the report.

Chair Hart summarized the discussion he had with Council Member Anderson regarding the downtown parking situation. Council Member Anderson indicated that the City Council will probably conduct a thorough study next year.

Committee Member Scott related the Council discussion regarding permeable parking lot materials and requested staff provide more information regarding the concept so that it can be determined if feasible and a standard process can be formulated.

Committee Member Donchak invited all to attend the North Beach Steering Committee meeting of May 30 where the final design for the parking lot improvements will be chosen. She will email the Committee Members with meeting specifics.

Report received and filed.

6. NEW BUSINESS

A. Tsunami Warning Signs

John Beck, Senior Park Planner, summarized the staff report. As part of the Multi Hazard Mitigation Plan, signs with the warning "Entering Tsunami Hazard Zone" are mandated in the appropriate beach zones. He displayed an example of the proposed signage and discussed the locations suggested by staff. Staff recommended the Committee Members discuss the proposed locations, provide input, and receive and file the report.

In response to questions, he noted the lowest lying areas would be the most likely to be affected in the event a tsunami occurred, but was not certain whether this would have an affect on property values; noted the funds for the signs would come from the City's maintenance fund; and advised the signs will be replaced when the City Master Signage program is implemented. He speculated that instructions what to do in the event of tsunami would be issued at a later time; noted that warnings would be broadcast over the Emergency Broadcast System; and was not sure whether literature regarding the area's tsunami risks would be considered disclosure in real estate property sales.

Committee Members suggested the public be alerted that signage is being installed as a result of the City's desire to comply with national standards by means of newspaper publicity, flyers handed out at community events, and pamphlets available at the Marine Safety Building.

John Beck, Senior Park Planner, reviewed the Future Agenda Items. At the request of Committee Members, he added an update of the Vortex Separation collection devises; a discussion of the future of the Coastal Advisory Committee, status check on the City's existing beach restroom facilities and the potential for additional facilities; and an update on the sand cleaning machine.

D. Beaches, Parks, and Recreation Department Activity Update of May 4, 2006, Received and Filed.

9. ITEMS FROM COMMITTEE MEMBERS

The Committee Members discussed the upcoming City Council vote on proposed municipal code modifications regarding bike and dog uses on the Beach Trail. They felt that Committee Members should attend the City Council meeting in order to properly convey the discussion that took place at last month's Committee meeting. John Beck, Senior Park Planner, agreed to email the Committee Members to remind them of the meeting.

Committee Liaison Maltinsky commended staff and the Committee Members for their spirit of cooperation, ability to compromise, and consideration for each others' opinions during the Beach Trail deliberations concerning bike and dog uses. In addition, he announced that the Seaview Condos project at the Pier Bowl had been rejected by the California Coastal Commission on a 9-0 vote.

Committee Member Hauswirth established from staff that standards and guidelines are in place and being enforced concerning development adjacent to coastal canyons.

Committee Member Nielson invited all to attend the upcoming Doheny Festival on June 24, which will feature old cars, trailers and photographs; sport and commercial fishing displays; and music and food. In addition, he invited Committee Members to volunteer to work at the blues festival on May 20-21 through the Surfrider Foundation.

Chair Hart remarked that the City's street sweeping program in the Neighborhood Pride areas seems to be working better, with more residents aware of the need to move their cars to accommodate the street sweeping trucks.

Committee Member Burror asked for volunteers to join the Parent Watch Program at Kirkorian Theaters, which generally involves being an adult presence and keeping kids out of trouble. Interested parties should call or email him for additional information.

TUESDAY, APRIL 11, 2006, 7:00 P.M.

A regular meeting of the Parks and Recreation Commission of the City of San Clemente was called to order on Tuesday, April 11, 2006, at 7:00 p.m. in the Ole Hanson Fireside Room of the Community Center.

3. APPROVAL OF MINUTES

A. March 14, 2006

Commissioner Vance requested the following changes to the March 14th, 2006 minutes:

Page 3, paragraph 6, first bulleted item should read, "The car show is committed to the second Sunday this year." Page 5, second paragraph, third line, change the word "cancelled" to "postponed."

MOTION BY VANCE, SECOND BY MALTINSKY, CARRIED (6-0-0), to approve the Parks and Recreation Commission minutes of March 14, 2006 as amended.

MOTION BY VANCE, SECOND BY McCONNELL, CARRIED (6-0-0), to approve the Parks and Recreation Commission minutes of March 28, 2006.

4. CURRENT COMMUNITY ACTIVITIES AND EVENTS

A. Future Plans for Casa Romantica

Chair Thomas introduced newly appointed Casa Romantica Executive Director John Lofgren who provided an update on the activities and plans for the Casa.

Mr. Lofgren provided a brief background on his experiences. He made the following comments: some momentum in fund raising was lost during the interim when the executive director position was vacant; the current project to reconfigure the parking lot to provide better and easier parking is scheduled for completion by April 22nd; a fountain is planned in the front area of the Casa; the Garden Club is invited on Arbor Day, April 22; programs for children are planned; work is progressing on the California native plant garden; the current art exhibit by San Clemente High School students is wonderful, and over 300 people turned out to view it; commented on the talent of the San Clemente High School students; advised that the San Clemente High School Music Department is invited to the Casa on May 14th. He stated he was excited to be a part of the San Clemente family, looked forwarded to getting to know everyone, and was excited to get the Casa on the map. He state he was looking forward to working with the Ocean Festival Committee as it relates to the Casa. He reminded everyone that the Casa is open to the public and invited all to come and enjoy the Casa.

5. PUBLIC INPUT

Recreation Manager Mead introduced Recreation Coordinator Peggy Lacayo, who is responsible for coordinating the Beaches, Parks and Recreation Department Beach Concert Series featured each summer. The Beach Concert Series was awarded the Community Life Achievement Award for 2005 by the California Park and Recreation Society and received a Certificate of Recognition for this achievement by the City Council at its April 4th meeting.

Coordinator Lacayo provided the Commission with background on the concert series; recognized its supporters and sponsors; noted the importance of these

resources; invited everyone to attend and provided dates for the upcoming series; thanked the Commission and Council for its support.

6. OLD BUSINESS

A. Beaches, Parks and Recreation Dept. Organizational Assessment

The Beaches, Parks and Recreation Department organizational assessment conducted by The Davis Company was continued for discussion from the special Parks and Recreation Commission meeting held on March 28, 2006.

Director King made the following comments: This was a continuation of the discussion from the special meeting on March 28, 2006 that introduced the funding and recommendation of the assessment; Mr. Davis made an extensive presentation on the analysis of the Department; the report has been revised and updated to contain the contributions by the Commission. He introduced Mike Davis, President of The Davis Company.

Mr. Davis distributed a copy of a memorandum addressed to the Director which was a follow-up of the requests by the Commission made at the special meeting on March 28th; offered to answer questions and provide follow-up on questions raised at the special meeting on March 28th.

Mr. Davis reviewed the contents of his memorandum addressed to Director King; advised of two changes in the rough estimate cost of recovery for 2005: the total for all programs should be \$3,267,690 while the Park Maintenance Expenditures figure should be \$5,312,890; referenced page 20 of the report

Mr. Davis reported he did not go through a cost recovery to identify all costs to arrive at a conclusion; budget data from late 2005 were used to calculate the figures; advised it was consistent with many cities.

Commissioner Waters questioned and Mr. Davis responded that there are no trends with cities with or those without maintenance; stated that the percentage should be in the mid-thirties; pointed out cost recovery, without maintenance included, is 41%, while cost recovery, with maintenance included, is 24%; stated that the City's financial staff advised that other costs involved are not included in these figures.

Mr. Davis advised the report encouraged exploring new partnerships by working first on small projects and then building on larger programs. He

advised that partnerships are not unusual. The memorandum provided examples of cities sharing and building partnerships, some not having a large tax base, such as Arroyo Grande.

Commissioner Maltinsky requested population and approximate revenue for those cities without a good tax base. Mr. Davis promised to provide this information; commented that the cities provided in the report were success stories.

Director King stated that Mr. Davis was provided information from the Long Term Financial Plan (LTFP); noted that the City Manager and Financial Officer are concerned with long term effects and trend lines; pointed out that there were opportunities to construct La Pata Vista Hermosa Park that would provide help to mitigate operational costs.

Commissioner Waters opined that all cities have the same swimming pool problems, and there has been discussion to work with other cities.

Mr. Davis provided examples of other cities that have experienced shared resources. He encouraged exploring new partnerships and reiterated building these partnerships with small projects at first, then using these successes to build larger programs.

After considerable discussion and debate, the following motion was made:

MOTION BY McCONNELL, SECOND BY VANCE, CARRIED (4-0-2),

- The Commission accepts the Davis organizational assessment, its findings and recommendations for the Beaches, Parks and Recreation Department;
- 2. The Commission concurs with the study recommendations as outlined on page 25 of the report;
- 3. The Commission recommends adoption of the report, its findings and recommendations by the San Clemente City Council; and
- 4. The Commission urges the City Manager and City Council to approve the decision package budget submitted by the Beaches, Parks and Recreation Department that include the "A" ranked Davis Report recommendations.

Commissioners Loy and Waters abstained.

Commissioner Vance requested that the report be submitted to City Council by Friday (4/13/06) to allow Council time to review the Commission's

comments before its meeting on 4/18; voiced concern about shifting some responsibilities before reviewing impacts; believed strongly, as an example, that Marine Safety should be mainly concerned with people on the beach and saving lives; mentioned that information related to parks and recreation should be incorporated in the planned City-wide survey.

Director King responded that City Treasurer Pall Gudgeirsson was researching the status of the survey.

7. NEW BUSINESS

A. Marblehead Coastal Parks and Trails Review

Director King advised that Beaches, Parks and Recreation retained the service of the design team of Richard Fisher, Landscape Architect consultant; Mr. Fisher, along with staff members Adrian Peters of SunCal, and Angela Woodward, Landscape Architect, made the presentation on the Marblehead Coastal Parks and Trails.

Mr. Fisher reviewed the contents of his report regarding Marblehead Coastal Parks and Trails; stated that the Marblehead Coastal Public Parks and Trails Master Plan received Council approval on March 2, 2004; detailed plans and specifications and approved amenities have been underway by the applicant's design team; noted that the documents went through the approval process and were approved by the California Coastal Commission; advised that the shared use parking lot improvement plans were also approved by the Department of State Architect.

Mr. Fisher invited the Commission, staff, and the audience to review the design documents displayed on tables along one side of the meeting room. He reviewed the key elements, viz., (1) public parks consisting of (a) Marblehead Sports Park, (b) Marblehead Ocean View Park, and (2) public trails consisting of (a) overall trails plan, (b) typical steps design, (c) typical informational signage. He pointed out and reviewed the amenities in each of the projects.

Mr. Fisher advised that the trails will consist of natural or soil cement and that the California Coastal Commission will not allow the trail along the Dudley Preserve; he described and pointed out the trail system on the conceptual plan.

Mr. Fisher referenced the Marblehead Coastal Sports Park conceptual plan and advised that the original parking lot plan was reworked, and, as a result, the number of parking spaces was increased from 85 parking spaces to 200 plus 20 unmarked spaces; advised a family restroom is planned in the area of Courtney's Sandcastle Playground; noted that each restroom stall will have a door. He pointed out other amenities in the parks such as shade structures and drinking fountains.

Commissioner Waters suggested a dog park be considered for Marblehead Coastal Park; reported that, currently, it is being used as one.

Commissioner Loy suggested call boxes for emergencies. Planner Beck advised that pay phones are a requirement in parks. Commissioner Maltinsky reported that CalTrans is removing some call boxes from the freeways because of reduced use and budget savings.

The Commission discussed including security cameras as a safety precaution since many agencies were using the cameras which are cost effective.

Mr. Fisher concluded by advising that the concept drawing of the landscaping for Lot V will be maintained by the homeowners association; reviewed the time lines of each project.

Director King complimented Mr. Fisher on a phenomenal job interfacing with the developer and City staff; thanked him, Adrian Peters and Angela Woodward for revisiting the parking lot plan which culminated in a modification to the plan by increasing parking spaces to 200.

Don Kunze, trail enthusiast and resident, thanked Mr. Fisher; commented he liked to see nice foot paths, signage and benches incorporated in all the trail system; commented that there were four miles of trails, and he wasn't sure how much was on sidewalks; questioned how he could get to the beach on a trail.

B. San Clemente Arts Association (SCAA) Partnership Request

Manager Steve Mead reviewed the contents of his report on a request from SCAA for the second year phase of the partnership and waiver of fees for the "Paint San Clemente" Plein Aire Competition to be held from June 24 through July 2, 2006; reviewed the partnership process; pointed out that funds raised by this program are for art supplies and scholarships for San

Clemente public schools; concluded that this was a professional run event, provided merit, value and benefits to the community by promotion of the arts in San Clemente.

Manager Mead responded to Chair Pro Tem McConnell's inquiry that last year, the first year of the request, the Commission recommended and Council approved waiver of half the fees which totaled approximately \$1,000; advised that fees were increased this year.

George Gooch, President of SCAA, spoke on behalf of SCAA, advising that SCAA will contribute about \$4,000 to promote the arts in the public school system; advised that this year some of the activities of the pottery class were being funded; stated that "Paint San Clemente" would be a first class event; hoped that Casa Romantica would be ready in future years for the artists; plans are to move to Marblehead Coastal for its "Paint San Clemente;" advised that SCAA was trying to display San Clemente in a good light, and there was good participation by the artists. He commented that SCAA member has increased membership to 325; advised that, when a painting is sold in the Art Gallery, SCAA receives 20% of the price, and those fees are used for scholarship programs; invited all to the "Quick Draw" scheduled at the Ole Hanson Beach Club.

As a result of the discussion, the Commission made the following motion.

MOTION BY VANCE, SECOND BY MALTINSKY, CARRIED (6-0-0), to recommend that City Council approve the second year phase of the partnership process and waive the fees associated with this 2006 event and future events.

8. COMMUNICATIONS

A. California and Pacific Southwest Recreation and Park Training Conference 2006

Chair Thomas reviewed the contents of his report on the CPRS Conference held in the City of Ontario, from March 15 through March 18; noted that Commissioners Maltinsky and McConnell attended the Conference; described the audience involvement in the play acting exercise entitled "Breaking Robert's Rules of Order;" indicated that it was a learning experience and enjoyable.

9. ITEMS FROM STAFF

A. Update on Beaches, Parks and Recreation Department Activities

Director King announced that a special meeting of the Parks and Recreation Commission is scheduled on Tuesday, April 25, at 7:00 p.m., in the Ole Hanson Fireside Room of the Community Center to review swimming pool options for the La Pata Vista Hermosa Park site; added that a community meeting is scheduled on Wednesday, April 26, at 6:30 p.m., at St. Clement's by-the-Sea Episcopal Church, 202 Avenida Aragon, to discuss Max Berg Plaza Park challenges.

Recreation Supervisor Gibson reported that the Easter Eggstravaganza is scheduled on Saturday, April 15, Cinco de Mayo on May 6th, and Memorial Day observance on May 29th.

Recreation Manager Mead reported work was progressing on the San Clemente Challenge.

B. Monthly Project Update by Senior Park Planner John Beck No report.

10. ITEMS FROM COMMISSIONERS

A. Sphere of Influence Report

 Commissioner Thomas no report.

- Sphere of influence: non-profit organizations / community events / youth / community organizations – Commissioners Vance and Waters

Commissioner Waters reiterated his request that a dog park be included at the Marblehead Coastal development.

Commissioner Vance reported she attended the Watershed Task Force meeting; wanted to be sure that a translator was invited to the Max Berg Plaza Park community meeting scheduled on Wednesday, April 26th; reminded everyone that Earth Day was scheduled on April 22, and the beach run was scheduled at Calafia on June 3; noted that the Watershed Task Force Committee has not received approval for non-profit status.

- Sphere of influence: schools (education), including CUSD sports field usage – Commissioner Van Auken – no report.
- Sphere of influence: youth activities Commissioner Loy reported that those attending ball games at Liberty Park have indicated to her that signage should be posted stating "no dogs off leash;" received requests to install a vending machine at Liberty Park to provide beverages other than water from the drinking fountains; reported that the large metal bases on the light poles could cause a hazard to skate boarders riding down the hill.

3. **NEW BUSINESS**

A. Options and Cost for La Pata Vista Hermosa Park Site Aquatic Center

Director Al King thanked the Commission for the special meeting called this evening; reminded the Commission that the master plan was recommended by the Parks and Recreation Commission and approved by City Council in December 2004; advised that Senior Park Planner John Beck was requested to conduct this special meeting to review special issues and present an overview of critical issues and general input comments from the Commission; advised that a meeting was conducted on April 19, 2006 to derive input from the stakeholders who endorsed Option 3A; noted that Planner Beck will then provide a brief overview of the remainder of the park; commented that members of the design team are present to answer questions.

Planner Beck reviewed the contents of his report; advised that pool option details were submitted for the Commission's consideration; reminded the Commission that the La Pata Vista Hermosa Master Plan was approved in December 2004; reviewed the amenities in each of the pool options and provided a brief description; described the directive given to the design team which was to provide

options for pool layout; stressed to the design team that the primary goal was commitment to increased aquatics service to the public while trimming project capital costs such as operations and maintenance costs; opined that increased costs are associated with global incidents; noted Option 3A combined the three pools that would increase recreation revenue with a better cost recovery and is supported by the aquatic shareholders.

Director King advised that staff was recommending Option 3A that improved cost recovery without compromising the design and, at the same time, with sensitivity and responsiveness to escalating costs; introduced the design team of Elaine Dove, landscape architect with the firm of David Volz Associates (DVD), and Randy Mendioroz, with the firm of Aquatic Design Group, subcontractor for DVD.

The meeting was open to public input.

Sandy Kos, assistant coach for the San Clemente Aquatic Team (SCAT), stated that she has utilized the city pool since 1960; visited a number of pools from Irvine to San Diego; reported that Coronado Island has a 50-meter pool that is similar to the concept presented; called attention to the importance of the water element, researching a water therapy pool, and the ability to change the pool in the future, if necessary; advised Chair Thomas that the Saddleback pool is heated by co-generation.

Mr. Mendioroz clarified that the code requires a filtration system to contain two heating elements; advised that there are ways to conserve energy like using thermal blankets and indicated that there were other cost saving methods; noted that 75% of cost is heating the water.

Ms. Kos responded to Commissioner McConnell that SCAT has funds that it would donate to the project and described its fund raising events.

Vicki Mierau, City of San Clemente water exercise instructor, stated that she has taught water exercise for the City for 20 years, was retiring, and introduced, Lisbeth Ganninger, who will succeed her; indicated she favored pool Option 3A; favored the inclusion of a therapy pool since it would be the only dedicated therapy pool in south Orange County and would pay for itself by generating revenue; suggested retrofitting the small pool at the Ole Hanson Beach Club to serve as a therapy pool since it would be less costly than constructing a new therapy pool; advised that many, who attend her classes, are from cities located near and around San Clemente; suggested methods to fund raise such as selling tiles for the pool area.

Lizabeth Ganninger, newly appointed instructor for therapeutic water exercise at the Ole Hanson pool and a physical therapist specializing in aquatics, commented that this is a great plan; advocated a specialty pool or retrofitting the small pool located at the Ole Hanson Beach Club; commented that a pool ramp would be better than a lift; opined that, based on the age of the population, it would be an incredible draw, would produce revenue, and pay for itself.

Mr. Mendioroz advised the small pool at the Beach Club is too large for a therapy pool; informed that, by reducing the footprint of the small pool, more deck space would be created or the pool could be split into two pools.

Director King advised that Vicki Mierau and Lizabeth Ganninger attended the stakeholders' meeting last week and presented the idea of the therapy pool which was presented to Randy Mendioroz for a comprehensive assessment on this idea; indicated that staff is interested in the idea and will return to the Commission with further information.

Manager Mead advised that staff recommends pool Option 3A because this option offers more recreation and flexibility than prior options.

Commissioner Maltinsky requested costs involved and offered a financial loan from his family to retrofit the small pool to a therapeutic pool at the Ole Hanson Beach Club; indicated support for pool option 3A.

Commissioner Loy commented that finding funding for the project was important; suggested that the doctors, who would refer their patients for pool therapy, may consider donating funds for the therapy pool; questioned whether input from the high school swim coaches was gathered; suggested polling citizens in the community not involved in competitive swimming; requested the percentage of time SCAT will use the pool.

Mike Eber, head coach of SCAT, informed the Commission that SCAT uses the pool from 3:00 p.m. to 6:30 p.m. daily; willingly shares the pool with City programmed classes at present and will do so at the new facility; advised that SCAT is a non-profit organization serving youngsters from ages six years to high school.

Commissioner McConnell commended staff on the plan; stressed the importance of resolving issues in the early stages; indicated support for pool Option 3A.

Commissioner Vance indicated support for pool Option 3A, calling it a great idea in utilizing overall space; requested complete information on costs before going forward; referred to the big picture, Plan I, questioned the repercussions involved.

Director King advised that staff has focused on the Commission's support and concurrence; stated that meetings with the stakeholders were held to provide the big picture.

Commissioner Vance commented she would like to have it all, including the artificial turf; remarked the therapy pool would serve people of all ages; suggested splitting the small pool at the Beach Club to accommodate therapy and a small pool for children.

Mr. Mendioroz informed the Commission that there are limitations because the Beach Club pools are on the same filtration system, and a six-foot separation wall between the two is necessary; opined it could impact the infrastructure.

In response to Commissioner Van Auken's suggestion, Director King advised that staff has been in communication with community-based organizations; briefed the YMCA staff on the vision and phasing of the project, visited its facilities in Laguna Niguel and Mission Viejo and anticipates meeting with YMCA staff in the future; informed that staff is scheduled to meet with Kent Campbell of the Boys and Girls Club next week.

The Commissioners were concerned with project costs and funding.

After discussion, the following motion was made:

MOTION BY VAN AUKEN, SECOND BY McCONNELL, that the Parks and Recreation Commission recommends to City Council pool Option 3A in phase I of the aquatic center for La Pata Vista Hermosa Park site; use Option 3B as an alternative, and requests staff study retrofitting the small pool at the Ole Hanson Beach Club for a therapy pool.

After considerable discussion, Commissioner Van Auken amended her motion to the following as follows:

MOVED BY VAN AUKEN, SECOND BY McCONNELL, CARRIED (6-0-0) to support staff recommendation of pool Option 3A, in Phase I, of the proposed aquatic center at La Pata Vista Hermosa Park.

MOVED BY VAN AUKEN, SECOND BY MALTINSKY, CARRIED (6-0-0), to request staff study retrofitting the small pool, for conversation to a therapeutic pool, at the Ole Hanson Beach Club.

Planner Beck reviewed the concept plans as described in the report; referenced the concept plans displayed on the wall in the meeting room; pointed out the amenities displayed in each plan; described the two restroom /storage buildings; advised that more capital cost information for the full Phase I improvements will be submitted; described the amenities planned for the aquatics bathhouse and restroom/storage buildings.

Commissioner Loy was informed that a high fence with pickets will prevent access to the aquatics facility. Manager Mead advised that this item will be addressed in more detail.

The Commissioners expressed concern regarding cost and funding for the project.

Commissioner McConnell requested information on the account balance in the Park Acquisition and Development Fund, how the Fund is replenished, and where the money comes from.

Director King advised that staff is concerned and conscious of the cost factor and anxious to find out the bottom line for the project; commented that the design process is necessary for something tangible to calculate cost; mentioned that this information will be available in May; stated that increasing costs were a concern.

Chair Thomas requested that access to the building, control and lifeguard space to include showers and bathroom facilities be considered. Planner Beck responded that the plan includes a room for lifeguards.

4. ADJOURNMENT

The meeting was adjourned to the regular adjourned meeting on May 9, 2006 at 7:00 p.m., in the Ole Hanson Fireside Room of the Community Center, 100 North Calle Seville, San Clemente, CA.



Pharmaceutical Pollution in the Sewer System

Environmental experts are concerned that pharmaceutical residuals from humans and animals are being introduced into the aquatic environment through discharges of treated domestic wastewater, treated industrial wastewater, commercial animal feeding operations, and surface application of manure. Scientific data from 1999 and 2000 support the claim that certain pharmaceuticals detected in surface water could cause adverse affects on the marine environment. The two largest sources of pharmaceuticals entering the sewer systems nationwide are thought to be hospitals and residents. Pharmaceuticals enter the sanitary sewer system through human excretion of partially metabolized pharmaceuticals and the disposal of unused medications down the toilet or domestic drains. Modern wastewater treatment facilities are incapable of removing these pollutants before passing them to receiving waters.

There is very little recent data related to the subject of pharmaceutical pollution because of the high cost of testing and the volume of pharmaceuticals available for human and animal consumption. The last peer-reviewed study was conducted by the U.S. Geological Survey (USGS) in 1999 and 2000. The USGS tested samples from waterways for 95 organic chemicals found in wastewater. The study found that very-low and low concentrations of at least one or more of the 95 chemicals were found in 80% of the water samples. Examples of the medications found included Acetaminophen, Steroids, Diltiazem, Codeine, antibiotics, and antimicrobials.

Currently, there are no formal pharmaceutical collection programs through the State of California, County of Orange, or cities in Orange County. That being said, the Household Hazardous Waste (HHW) program at the Orange County landfill will accept pharmaceutical waste from residents as long as they deliver it to the landfill. Although the recent focus of the Orange County HHW program is the proper disposal of used batteries and fluorescent light bulbs, the facility also accepts pharmaceuticals, paint, oil, automotive fluids, and other toxic chemicals. Local governments generally do not have the resources to coordinate hazardous waste collection events within their cities and must encourage residents to dispose of hazardous waste at the local landfill HHW collection facility. At this point in time, residents should be encouraged to return unused or expired medications to the pharmacy where they were purchased, deliver them to the Orange County landfill, or deposit them in the trash instead of flushing them down the toilet or drain. Pharmaceutical pollution is a problem facing cities nationwide. In the future it will be important for government officials, pharmaceutical corporations, healthcare executives, wastewater treatment experts, scientists, and landfill operators to work together towards developing a formal solution to pharmaceutical pollution.

helps him attract customers with a comfortable atmosphere. When his auto repair shop opened three years back, he found a property that had been poorly maintained by its . former owners.

"We spent a week digging built back in the '70s, when the mentality was different. They would wash their engines out into one area ...there was no grass there. Now there's grass and a few palm trees.

But while awards and informational booths raised environmental awareness down by the pier. San Clementeans were getting their hands dirty elsewhere as well.

Earlier in the day, around 50 friends and family members of late patriarch Don Divel gathered at Max Berg Plaza Park for a ceremonial tree planting and service.

Downtown Business Associ-President Michael ation Kaupp helped organize the event, bringing a Monterey Cyprus to be planted in the park. The Cyprus; a non-native plant 🖈 brought to the area during the town's founding, typically has a lifespan of 80 years-roughly the same age as both San Clemente and Divel at the time of his passing.

"It overwhelmed me how * many people came out for this," said Divel's wife, Lois. "I know how proud my husband would have been. He wouldn't have expected it."

Several other groves of trees have been planted in the park in memoriam of other San Clementeans, Kaupp said! Sitting across from St. Clement's By the Sea Episcopal Church, it's a prime location for a Divel tribute.

His daughter, Martha Divel-Sanchez, lives down the street from the park, in the same! house her father raised her in:

"He would be very pleased," Divel-Sanchez said. "He was the patriarch, and he was proud to be the patriarch."

Kaupp; wno nas made war personal mission to help reform est old San Clemente, didn't stop at the park tree planting. He had brought 100 trees back with him from Santa Barbara carlier in the week, and gave away all of them by the end of the day.

Fifteen had been reserved prior to Earth Day, while another 85 were handed out at the Casa Romantica Cultural Center and Gardens, Kaupp said he'd be bringing down anmwkaupp@cox.net.

Because of their relatively. short lifespan, many of the original trees brought to the area by founder Ole Hanson have begun to die out in recent? vears. For the past five years, Kaupp has planted hundreds of trees in parks and schools, and given many away for local yards, in an effort to preserve San Clemente's historical atmosphere.

"They're a sturdy wind swept gutsy-looking wtree Kaupp explained, adding that they go well with the area's; bulky Spanish architecture., "Ole knew what he was doing when he brought these down."


He said the Cyprus has at tendency to naturalize, mean ing that within a few years of planting, it only requires local ground water rather than irri?
