### **Investment Advisory Committee Minutes**

### Special Meeting – July 29, 2013

The presentation by **Chandler Asset Management** was given by Kay Chandler, President and Jason Schmitt, Portfolio Manager. The two also answered questions posed by the committee.

# (3) REVIEW AND DISCUSS ALL 3 EXTERNAL ADVISORY SERVICES FIRMS PRESENTATIONS AND PROVIDE RECOMMENDATIONS

The Committee discussed the 3 external Advisory Services firms that have provided presentations, namely Cutwater Asset Management, United American Capital Corporation, and Chandler Asset Management. Discussion included the size and experience of the firms, the firms' presentations, potential fees, and insurance coverage requirements.

After discussion, it was determined that City Treasurer, Mark Taylor, would pursue follow-up information from the firms and provide the information back to the committee at a Special Meeting in two weeks.

Mark Taylor will contact Chandler and enquire if they are willing to charge their investment advisory fees only on assets after they mature and are subsequently reinvested by Chandler. He will also contact UACC to ask them why their liability insurance limits are less than most of the other firms we have reviewed and if they are willing to increase the limits.
