7. BUSINESS SESSION

A. Revised Recognized Obligation Payment Schedule (ROPS) and Successor Agency's Administrative Budget

Financial Services Manager Rahn reviewed the contents of the Administrative Report and responded to inquiries.

<u>Frank Battaile</u>, attorney representing Dan Bogoshian, asserted that the RDA did not spend its money appropriately and that the funds were never appropriately accounted for; stated that the RDA received over \$12 million in revenue, but spent less than \$1 million on capital improvement projects; stated that millions of dollars were spent on the beach trail, but contended that the beach trail was not an appropriate use for RDA funds; suggested that the Department of Finance should do an independent audit of the RDA's total finances and expenditures; stated that the Pier Bowl continues to be blighted and asserted that the Successor Agency is obligated to discharge the obligations that the RDA failed to discharge.

<u>Guy Varriano</u>, President of the Casa Romantica Cultural Center and Gardens, stated that he was involved with the \$3 million renovation of the Casa Romantica; stated that the Casa Romantica is now the crown jewel of San Clemente; commented that the mission of the Casa Romantica Cultural Center and Gardens is to provide educational and cultural opportunities for people of all ages and backgrounds; related that he will present several areas of operational concerns to the Oversight Board in the next 90 days.
