APPROVAL OF THE REVISED RECOGNIZED OBLIGATION PAYMENT SCHEDULE (ROPS) AND SUCCESSOR

AGENCY'S ADMINISTRATIVE BUDGET

Summary:

On April 4, 2012 the Oversight Board approved the Recognized Obligation Payment Schedule (ROPS) and the Successor Agency's Administrative Budget for the period of February 1, 2012 through June 30, 2012. The ROPS and Successor Agency's Administrative Budget was then submitted as required to the California Department of Finance. Department of Finance staff subsequently contacted City staff and indicated that the ROPS and Successor Agency's Administrative Budgets must cover the period of January 1, 2012 through June 30, 2012.

The original ROPS was submitted to the State prior to April 15th, the required due date. Mary Anne Ruiz, the Department of Finance Analyst who communicated with the City to modify the ROPS to include January, has confirmed that the revised ROPS may be submitted on April 16th, as the 15th falls on a Sunday.

The ROPS and Successor Agency's Administrative Budgets have been revised to include January, which was not included in the original documentation approved by the Oversight Board and submitted to the Department of Finance.

A future ROPS will need to be prepared for additional costs relating to the period of July 1, 2012 through December 31, 2012, which is scheduled for Oversight Board consideration at an Adjourned Regular Meeting to be held on June 27, 2012.

- 1) Approve the revised Recognized Obligation Payment Schedule (ROPS) for the period of January 1, 2012 through June 30, 2012.
- 2) Approve the revised Administrative budget for operations from January 1, 2012 to June 30, 2012 in relation to the dissolution of the former Redevelopment Agency.
