Mayor Brown presented a Proclamation to Janet Dunford, Crime Prevention Specialist, designating August 5, 2014 as National Night Out.

**2. ORAL COMMUNICATIONS (PART 1)****Group Homes**

Monica Burick, San Clemente, read a letter signed by approximately 560 San Clemente residents expressing concerns with group homes; requested that the issue of group homes be agendized for an upcoming Council meeting; urged Council to address problems associated with group homes.

Harold Warman, San Clemente, voiced concern with unlicensed group home facilities; commented that because group homes are not required to be registered, the City does not know where most of them are located.

Darius Vasefi, San Clemente, stated that a group home across the street from his residence is creating a nuisance and causing safety concerns; urged Council to take aggressive action to control the situation.

At the direction of Council, Legal Counsel Oderman reported that Council, at its meeting of June 17, 2014, voted to provide amicus support and contribute \$5,000 to assist the City of Newport Beach's group home litigation; explained the challenges that the City faces in regulating group homes, noting that the City's local control has been taken away to a great extent by both the federal and state governments; estimated that the United States Supreme Court will make a decision by Fall 2014 as to whether or not it will hear Newport Beach's group home litigation matter.

7. **PUBLIC HEARINGS**

A. **SB2 Emergency Homeless Shelter Zone and Development Standards**

Public Hearing concerning the SB 2 Emergency Homeless Shelter Zone and Development Standards.

City Legal Counsel Oderman provided opening remarks concerning Senate Bill 2, and the City's requirement to provide zoning for emergency shelters within the City.

Associate Planner Gregg narrated a PowerPoint presentation entitled "Draft SB 2 Zoning and Development Standards" and responded to Council inquiries. A copy of Ms. Gregg's PowerPoint is on file in the City Clerk Department.

Mayor Brown opened the Public Hearing.

Barbara Scheiman, Social Worker, San Clemente Hospital, spoke in support of designating areas for a homeless shelter; suggested that an emergency shelter for the homeless would free hospital beds for emergency room patients.

Sandra Weaver, San Clemente, spoke in support of a homeless shelter and urged Council to make this project a priority.

Ed Connor, iHOPE, spoke in support of a homeless shelter but urged Council to choose a location other than the Rancho San Clemente Business Park; suggested the Rancho San Clemente triangle site would provide a good location for a homeless shelter.

Richard Henderson, Dana Point, urged Council to consider designating its surplus property as potential homeless shelter sites.

William Miller, Lake Forest, suggested that the Rancho San Clemente Business Park is not a good location for a homeless shelter; urged Council to consider a location that is not at the top of a hill to facilitate easy access.

Leslie Davis, San Clemente, encouraged Council to adopt the Planning Commission recommendations.

Kay Childs, Human Affairs Committee, thanked the Planning Commission and staff for their work; suggested that a homeless shelter will provide relief at the emergency room at Saddleback Hospital San Clemente; stated a homeless shelter in the Rancho San Clemente Business Park would reduce the risk of fires since cooking would occur inside the shelter.

Richard Metcalf, San Clemente, urged Council to consider a solution that would yield positive results for both the City and the homeless population; suggested the Water Reclamation Plant as a potential shelter facility.

Tom Alexander, San Clemente, asserted that the presence of homeless individuals in the Rancho San Clemente Business Park will degrade the Park; suggested that an acceptable compromise would be to allow churches to provide 10 beds each to meet the City's SB2 requirements.

Jack Kulp, San Clemente, urged that the homeless shelter overlay in the Rancho San Clemente Business Park should be limited to churches in the Business Park, and not expanded to encompass the entire Park; noted that allowing 50 beds at the Calle de Industrias site, combined with 10 beds each at the three churches within the Rancho San Clemente Business Park and two churches outside the Park will result in 100 beds for the homeless.

Thomas Mauriello, attorney representing San Clemente Business Park, noted the economic benefits that the business park provides to the community and asserted that negative consequences would result from designating the full park for potential homeless shelter development; conveyed the Rancho San Clemente Business Park's support to allow the three churches in the business park to provide 10 beds each to help the City meet its SB2 requirements.

Vonne Barnes, Rancho San Clemente Community Association Board Member, showed photographs displaying homeless people living in open space areas near the business park; urged Council to consider the Calle de Industrias site, Water Reclamation Plant or churches to meet the City's SB 2 requirements. A copy of the photographs are on file in the City Clerk Department.

Raymond Toal, San Clemente, urged Council to consider the Calle de Industrias site for the homeless shelter.

Tom Barnes, San Clemente, urged Council to consider the Calle de Industrias site and churches for homeless shelters; opined that it would be inappropriate to site a homeless shelter in a high fire severity zone.

Bob Mortimer, San Clemente, stated that he is against a homeless shelter in the Rancho San Clemente Business Park for fire and safety reasons.

David Brant, San Clemente, suggested the business park is not an appropriate location for a homeless shelter due to its proximity to schools and parks.

Nampet Panichpant-Michelson, San Clemente, spoke concerning the homeless problem in California.

Anthony LaFrano, San Clemente, urged Council to oppose a homeless shelter in San Clemente; voiced concern that a homeless shelter would compromise public safety.

Jim Smith, San Clemente, voiced opposition to a homeless shelter in the Rancho San Clemente Business Park.

Lindsey Spaethe, San Clemente, urged Council to consider the Rancho San Clemente triangle site, Calle de Industrias site, and local churches as options for potential homeless shelters.

Scott McGurk, San Clemente, spoke in opposition to allowing a homeless shelter in the Rancho San Clemente Business Park; suggested that the location behind Denny's is best suited for the subject land use.

Jean Braun, San Clemente, spoke in support of SB 2, but asserted that the Rancho San Clemente Business Park is an inappropriate location for a homeless shelter.

Vasko Mitzev, San Clemente, suggested that Council is not prepared to make a decision on SB 2; spoke in support of churches providing emergency shelter for the homeless population; stated that homeless persons should not be clustered in a large facility.

Jill Mitzev, San Clemente, stated that she is speaking on behalf of 62 North Beach residents; spoke in opposition to the placement of a 50-bed homeless shelter in the North Beach area due to concerns that it would jeopardize safety; opined that a homeless shelter in the vicinity of the Boys and Girls Club would be inappropriate.

Denice Tittle, San Clemente, suggested that the City's homeless population will not utilize a homeless shelter in the business park.

Rob Johnston, San Clemente, suggested a homeless shelter in the business park is not compatible with the businesses and will weaken the viability of the business park.

Nancy McIntyre, San Clemente, spoke in support of the Staff and Planning Commission recommendation.

Sherry Clifford, San Clemente, suggested that a homeless shelter in the business park will increase crime in the area.

Philip Schwartze, San Clemente, urged Council to ensure that homeless shelters are near public transportation and away from public and private schools and daycare facilities.

Justin McCarthy, San Clemente, suggested that prison realignment residents could populate a homeless shelter in the City.

Elly Harris, North Beach Community Association, urged Council to not permit a homeless shelter in the North Beach area since it will stifle revitalization.

Mitch Pierce, San Clemente, urged Council to not designate the business park as a location for a potential homeless shelter, stating safety concerns; opined that the Calle de Industrias site and churches make the most sense for homeless shelters.

Brad Shapiro, Laguna Niguel, expressed concerns with allowing homeless facilities in the Rancho San Clemente Business Park and suggested that a shelter would deter businesses.

John Yim, San Clemente, urged Council to eliminate the business park as an option for a homeless shelter due to fire and safety concerns.

Alan Korsen, San Clemente, suggested the business park is ill-suited for a homeless shelter because of the potential for fire and safety problems.

Cindy Fritz, San Clemente, opined that the location behind Denny's is not suitable for a homeless shelter.

There being no others desiring to speak to this issue, Mayor Brown closed the Public Hearing.

To accommodate an additional speaker, Mayor Brown reopened the Public Hearing.

Rev. Patrick Crerar, San Clemente, spoke in support of a homeless shelter in San Clemente; urged Council to approve the Staff and Planning Commission recommendation.

There being no others desiring to speak to this issue, Mayor Brown closed the Public Hearing.

### **MEETING RECESSED**

Council recessed at 9:20 p.m. and reconvened at 9:35 p.m., with all members present.

During the course of deliberations, Council raised the possibility of placing an overlay on the City's public zones (with the exception of Capistrano Unified School District properties) to allow the development of homeless shelters. Because the Public Hearing notice for this meeting did not specify that public zones would be among those zones that Council may consider as potential homeless shelter sites, Council determined to re-open and continue the Public Hearing to the Council meeting of August 19, 2014 to accommodate re-noticing of the Public Hearing. Staff was directed to

publish a revised Public Hearing notice that adds public zones to the zones that Council will consider in meeting its SB2 requirement.

MOTION BY MAYOR BROWN, SECOND BY COUNCILMEMBER EVERT, CARRIED 5-0, to re-open and continue the Public Hearing to the August 19, 2014 Council meeting.

Mayor Pro Tem Hamm left the meeting at 10:53 p.m.

3. Add the Fabricante property to the list of marketable properties.
4. Approve the leasing of the City-owned property at 1100 North El Camino Real in accordance with Policy #901-1 Section 5.5.

**OCTA Update**

Councilmember Donchak provided an update on OCTA matters, noting as follows: 1) The OC Fair Express bus service provides transportation from San Juan Capistrano to the Orange County Fair; and 2) Michael Kraman, Acting CEO of the Transportation Corridor Agencies, reported at the last OCTA meeting that San Diego County has reversed its position and is now including a 241 toll road alignment in its long term plan.
