SUBJECT: Public Hearing Draft Centennial General Plan: Review 1) the Draft

Environmental Impact Report (DEIR) and 2) the unresolved policy issues,

including revisions to the Glossary and related changes.

BACKGROUND

At this meeting, the Commission should 1) review the enclosed Draft General Plan Environmental Impact Report and 2) resolve the remaining general plan policy issues, as described in Table 1. The "City Council Hearing Draft" Centennial General Plan was provided at the July 10th meeting and is referenced in the Table. Because of the quick turnaround between the July 10th meeting and the agenda report deadline for the July 17th meeting, there was not sufficient time to provide a detailed evaluation with the agenda packet of each of the listed items. Additional details will be provided and staff and the consultant will summarize the changes and/or additions at the meeting. If possible, the Commission should give final direction on text or graphic changes. This would allow the possibility of final Commission action on the General Plan, DEIR and related documents at the Commission's July 24th, 2013 special meeting.

At its June 26th meeting, the Planning Commission received an introduction to the DEIR from the City's general plan/environmental consultant, reviewed the draft Glossary and discussed several unresolved issues. Commissioner questions and comments also generated discussion and several policy changes. At the meeting, the Commission directed staff and the consultant to return with changes to the items summarized in Table 1.

Draft Environmental Impact Report

The Commission should review and consider the Executive Summary, Project Description, Impact and Mitigation Summary and Alternatives. Particularly important is the relationship between proposed land use changes, potential environmental impacts and proposed mitigation measures. The consultant and staff will be available at the meeting to respond to questions and provide additional background as needed. The DEIR has been distributed to the State Clearinghouse and many public agencies, including Capistrano Unified School District, Caltrans, and the County of Orange. It is available on the City's website and in "hard copy" at the San Clemente Public Library, City Hall and City Offices at 910 Calle Negocio. CDs of the DEIR and Appendix are available at the Community Development Department on Calle Negocio. A 45-day public review period has begun. During this period, individuals, groups and agencies may submit comments on the DEIR. As required under the California Environmental Quality Act (CEQA), the consultant will

respond to comments in the Final EIR (FEIR), to be considered by the City Council as part of any final action on the Draft General Plan and related documents.

Unresolved Issues

At its July 10th meeting, the Commission directed that several unresolved issues, including several terms in the Draft Glossary, return for Commission action. Those items are listed below.
