Summary:

On December 4, 2012, the City Council directed staff to prepare contract amendments to extend the following contracts for 5 years: the Inland Trail contract; the Beach Trail Maintenance contract; the Tree Maintenance contract; the Streetscape Maintenance contract; the Sidewalk Pressure Washing contract; the Parks Maintenance contract; the Beach and Park Restroom Maintenance contract; the Landscape Rodent Control contract; the Beach Maintenance contract; the Beach Equipment Operator contract; the Steed Park Maintenance contract; and the Negocio Landscape Maintenance Contract.

Stewart and Associates for Steed Park Landscape Maintenance with a contract end date of June 30, 2018 and no changes to compensation and the addition of the maintenance responsibilities for Ralph's Skate Court and the Baron Dog Playgrounds;
	12. Execute Contract Amendment by and between the City of San Clemente and TruGreen LandCare for Negocio Landscape Maintenance with a contract end date of June 30, 2018 and a 5% reduction in contract cost.

Fiscal Impact:

\$88,570 in annual savings each contract year, and \$25,000 in additional services.
