**ORDINANCE NO.**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA, AMENDING SAN CLEMENTE MUNICIPAL CODE SECTION 9.12.06 RELATING TO THE USE OF MUNICIPAL PARKS AND TRAILS**

**WHEREAS**, Municipal Code Section 9.12.060(a) provides that no person shall remain or be in any municipal park between the hours of ten (10:00) p.m. and six (6:00) a.m., except as provided elsewhere within Section 9.12.060; and

**WHEREAS**, Municipal Code Sections 9.12.060(b) and 9.12.060(c) specify City parks that have closure hours that differ from Section 9.12.060(a); and

**WHEREAS**, Park Semper Fi is not currently identified as a City park with closure hours that vary from Section 9.12.060(a); and

**WHEREAS**, to lessen the opportunity for vandalism and loitering at Park Semper Fi, the City desires to amend the Code of the City of San Clemente to provide that no person shall remain or be in Park Semper Fi after sunset and before sunrise.

**NOW, THEREFORE**, the City Council of the City of San Clemente, California, hereby ordains as follows:

**Section 1:** A new Subsection C shall be added to Section 9.12.060 of the Code of the City of San Clemente to read as follows:

"No person shall remain or be in Park Semper Fi after sunset and before sunrise."

**Section 2:** Existing Subsections C through G of Section 9.12.060 of the Code of the City of San Clemente shall be re-lettered as Subsections D through H to accommodate the insertion of the new Subsection (C).

**Section 3:** The City Clerk shall certify to the passage of this ordinance and cause the same to be published as required by law, and the same shall take effect as provided by law.
