**Subject:** *CITY REPRESENTATIVE – ORANGE COUNTY VECTOR CONTROL DISTRICT BOARD OF TRUSTEES*

**Fiscal Impact:** None.

**Summary:** Jim Dahl's two-year term as the City's representative to the Orange County Vector Control District Board of Trustees will expire on December 31, 2013. At its meeting of December 3, 2013, Council directed Staff to advertise the vacancy and to solicit applications from San Clemente registered voters interested in serving in this capacity. The position was advertised, pursuant to the Maddy Act, in the Sun Post News as well as the City website for 10 days. The City received one application, from Jim Dahl (current incumbent), by the December 9, 2013 deadline. Mr. Dahl has been invited to attend this meeting in the event Council wishes to conduct an interview.

**Recommendation:** STAFF RECOMMENDS THAT the City Council determine whether to appoint Jim Dahl to serve as the City representative on the Orange County Vector Control District Board of Trustees for either a two-year or four-year term of office.
