Subject: *PROHIBIT PARKING AT CALLE NEGOCIO AND CALLE TREPADORA BUS STOP.*

Summary: Calle Negocio is two-lane, commercial street which intersects Calle Amanecer. On-street parking is allowed on both sides of the street. The Orange County Transportation Authority (OCTA) operates a bus stop on the south west corner of Calle Negocio and Calle Trepadora. Staff received a request from OCTA to provide a no-parking zone at the bus stop. OCTA reported that vehicles often park right next to the bus stop sign and block the buses from servicing the stop. In order to provide necessary safety movement of the buses, staff concurs with OCTA's request and recommends prohibiting parking on the southwest corner of Calle Negocio at Calle Trepadora for sixty (60) feet. Prohibiting parking at this location will result in the loss of three (3) parking spaces.

At its regular June 6, 2012 meeting, The Planning Commission unanimously approved staff's recommendation as described herein.

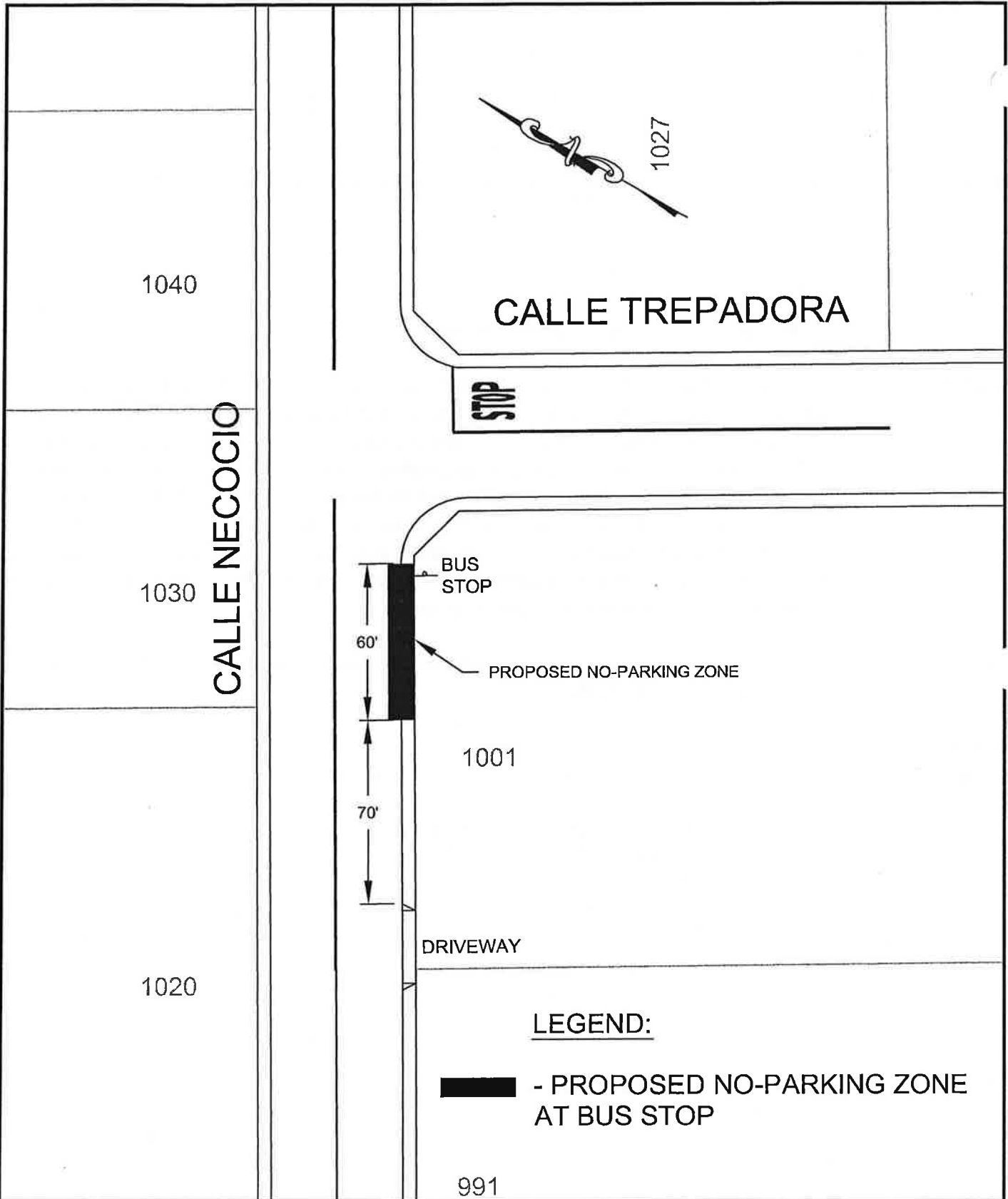
1. Approve prohibiting parking on the southwest corner of Calle Negocio and Calle Trepadora for sixty (60) feet; and

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA, AMENDING MASTER TRAFFIC RESOLUTION NO. 1846, ESTABLISHING 'NO PARKING AREAS' ON CALLE NEGOCIO.

WHEREAS, the City reviews various locations to improve safety and traffic conditions; and

WHEREAS, the City of San Clemente Planning Commission ("Planning Commission"), at its regular meeting of June 6, 2012 made a recommendation to the City of San Clemente City Council ("City Council") to approve a parking prohibition at the location listed below; and

WHEREAS, the City Council has considered the recommendation by the Planning Commission, and the information provided by City staff and now wishes to implement the recommended prohibition.

NOW, THEREFORE, The City Council of the City of San Clemente does hereby resolve as follows:

Section 1. The above recitals are true and correct.

Section 2. Master Traffic Resolution No. 1846, Section 23, entitled "No Parking Areas", is hereby amended by adding the following subsection:

23.n-10 Calle Negocio, south side, from the west curb return at Calle Trepadora to a point sixty (60) feet westerly.

Section 3. The City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.
