**Subject:** ***PROHIBIT PARKING ON CAMINO MIRA COSTA AT VISTA AZUL (DANA POINT).***

**Summary:** Staff received a resident's request to prohibit parking on the northwest side of Camino Mira Costa at Vista Azul to improve corner line-of-sight for drivers exiting Vista Azul. Staff checked the location and determined that sight could be improved by prohibiting parking on the northwest side of Camino Mira Costa on both corners of the intersection.

Camino Mira Costa is a secondary arterial, has two thru-lanes in each direction plus a center-turn-lane, sidewalks and street lights along both sides, and a posted speed limit of 35 miles per hour. This neighborhood has both single-family and multi-unit homes. There were no reported accidents at the Vista Azul intersection from January 1, 2006 though November 30, 2011. The other intersections along the northwest side of Camino Mira Costa at Camino La Veta, Calle Borrego, and Calle Guaymas all have red curb 65 feet north and 20 feet south of the intersection to improve the line of sight for drivers existing onto Camino Mira Costa.

Approving parking prohibitions 65 feet northwest and 20 feet southwest of the intersection would result in the loss of four parking spaces. While Staff understands the importance of maximizing on street parking for the surrounding homes, we also need to facilitate adequate line of sight at this intersection consistent with the other intersections along this roadway.

At its regular June 6, 2012 meeting, The Planning Commission unanimously approved staff's recommendation as described herein.

**Recommended Action:**

PLANNING COMMISSION AND STAFF RECOMMEND THAT THE CITY COUNCIL:

1. Approve prohibiting parking on the west side of Camino Mira Costa, from Vista Azul curb return in a northeasterly direction for a distance of sixty-five (65) feet and in a southwesterly direction for a distance of twenty (20) feet; and
2. Adopt Resolution No. \_\_\_\_\_, entitled "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA, AMENDING MASTER TRAFFIC RESOLUTION NO. 1846, ESTABLISHING 'NO PARKING AREAS' ON CAMINO MIRA COSTA."

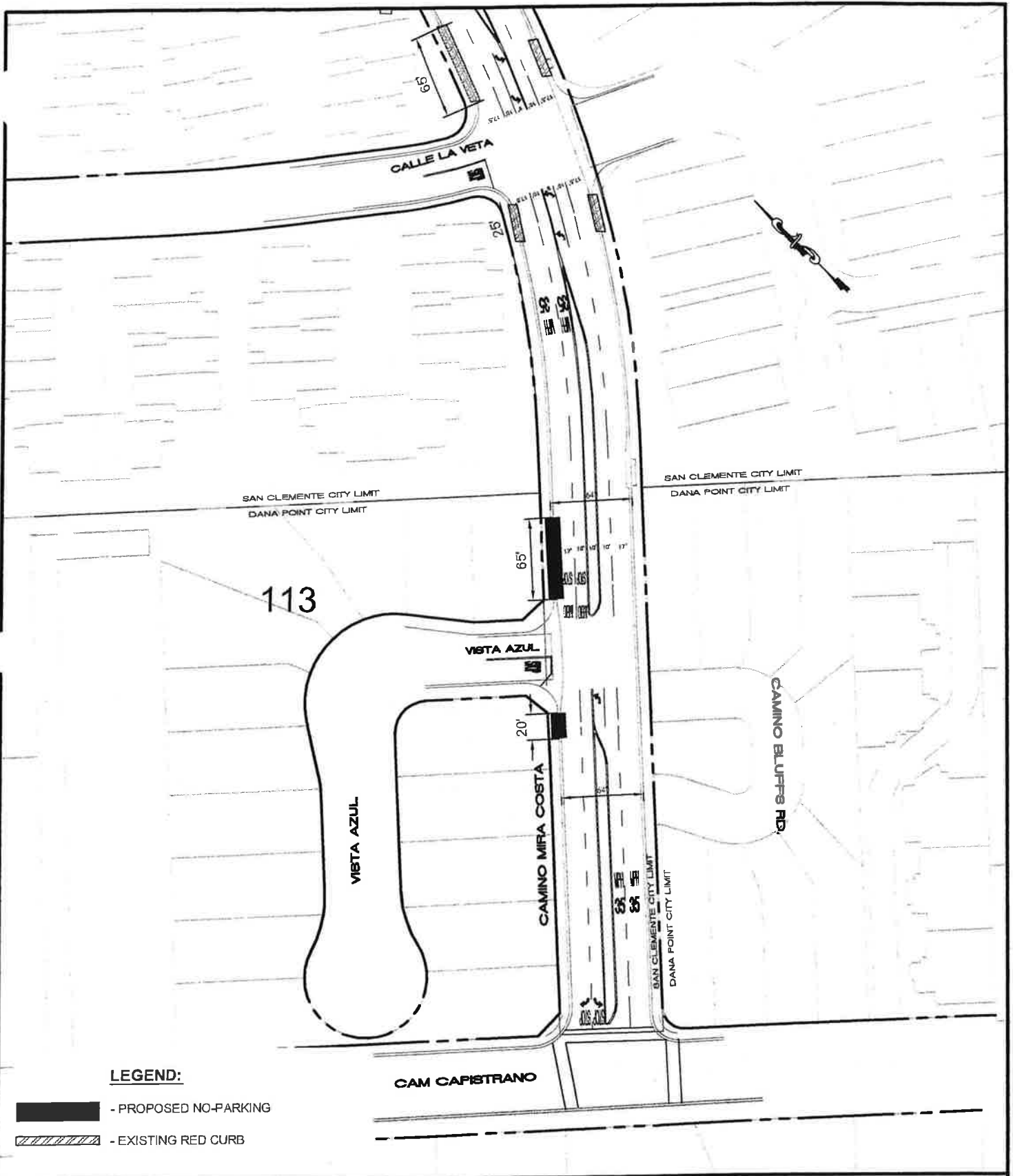



**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE,

**WHEREAS**, the City reviews various locations to improve safety and traffic conditions; and

**WHEREAS**, the City of San Clemente Planning Commission ("Planning Commission"), at its regular meeting of June 6, 2012 made a recommendation to the City of San Clemente City Council ("City Council") to approve the parking prohibitions at the locations listed below; and

**WHEREAS**, the City Council has considered the recommendation by the Planning Commission, and the information provided by City staff and now wishes to implement the recommended prohibitions.

NOW, THEREFORE, The City Council of the City of San Clemente does hereby resolve as follows:

Section 1. The above recitals are true and correct.

Section 2. Master Traffic Resolution No. 1846, Section 23, entitled "No Parking Areas", is hereby amended by adding the following subsections:

23.m-50c Camino Mira Costa, from Vista Azul curb return in the northeasterly direction for a distance of sixty-five (65) feet.

23.m-50d Camino Mira Costa, from Vista Azul curb return in the southwesterly direction for a distance of twenty (20) feet.

Section 3. The City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.
