AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA, AMENDING CHAPTER 10 OF THE MUNICIPAL CODE CONCERNING SPEED ZONES ON CERTAIN CITY STREETS

WHEREAS, the City has conducted additional speed surveys and engineering studies upon certain streets in the City; and

WHEREAS, the City of San Clemente Planning Commission ("Planning Commission") at their regular meeting of June 6, 2012 made a recommendation to the City of San Clemente City Council ("City Council") to approve the establishment of speed limits based on recent speed surveys and engineering surveys.

**NOW, THEREFORE**, the City Council of the City of San Clemente DOES HEREBY ORDAIN as follows:

<u>Section 1</u>: Section 10.16.020 of the Municipal Code of San Clemente, entitled "Decrease of state law maximum speed", is hereby amended by modifying the following to the list of City streets and declared prima facie speed limits set forth therein:

Name of Street or Portion Affected

Declared Prima Facie
Speed Limit

Pico, Avenida

Thirty-five miles per hour

from El Camino Real to Calle De Los Molinos

<u>Section 2</u>: The City Clerk shall certify to the passage of this ordinance and cause the same to be published as required by law, and the same shall take effect as provided by law.
