1. CALL TO ORDER/ PLEDGE OF ALLEGIANCE

Chair Hart called the meeting to order at 7:00 p.m. Committee Member Ambrose led the Pledge of Allegiance.

3. APPROVAL OF MINUTES

A. Minutes of the Regular CAC Meeting of March 13, 2014

IT WAS MOVED BY COMMITTEE MEMBER BROWN, SECONDED BY COMMITTEE MEMBER AMBROSE, AND CARRIED 5-0-1, WITH COMMITTEE MEMBER NIELSEN ABSTAINING, to receive and file the minutes of the regular meeting of March 13, 2014, with the following revisions:

Page 2, after the 1st paragraph, insert the following paragraph: "Committee Member Ambrose suggested that now is the time to ask questions because the topic is agendized for discussion at the meeting. Committee Member Smith responded that he is not ready to discuss his entire list of questions because there are so many of them."

Page 2, 3rd paragraph, 1st sentence, following "stated that" insert "he did not want to put his questions in writing and"

Page 2, last paragraph, add to the end of the 1st sentence, "only if one was warranted." Last sentence, replace "opinions available" with "opinions, past discussions, and staff reports available."

7. NEW BUSINESS

A. Sand Replenishment Update

Mary Vondrak, Senior Management Analyst, reviewed Tom Bonigut, Assistant City Engineer's staff report, an update on the Beach Sand Replenishment Project, including a brief summary of the proposed project, current status and anticipated next steps, and funding overview. Staff recommended the Committee hear the report and provide input.

In response to questions from the Committee Members, Senior Management Analyst Vondrak confirmed that the City has the option to opt out of the project after completion of any of the designated phases; informed that the City is not locked into a location for the sand source.

Committee Member Nielsen commented that the quality of the sand available in Oceanside must not be acceptable because Oceanside imported sand from Del Mar for its sand replenishment project; speculated if the quality of excess sand in Dana Point is high, the City of Dana Point may want to keep it for its own projects. He established for the record that the City is not locked in or obligated to use sand in the City of Oceanside as its sand source.

Commissioner Brown reported that he attended the budget planning session, where several Councilmembers expressed concern about the amount of funds necessary from the City for this project and speculated that public support in the way of bonds or increased taxes may be necessary to fund the project.

Report received and filed.

B. Update on Plastic Bag Ban

Senior Management Analyst Vondrak reviewed the staff report, an update on single-use plastic grocery bag bans across California including histories of bans, a listing of California cities and counties with current single-use plastic grocery bag ordinances, and an update on State Legislation that would phase out single-use plastic grocery bags statewide. Staff recommended the Committee provide input and receive and file the staff report.

Committee Member Ambrose commented that she distributes reusable bags provided by the City while shopping and at the City Council meeting and noted that people have been very supportive. There are two types of bags and they are sturdy and easy to clean.

Committee Member Nielsen reported that he spent time in a diverse area of San Pedro and spoke to many people who expressed favor of the ban in effect there, especially as it keeps single use bags from entering the ocean. For the record, he commented that he is ashamed of San Clemente for not supporting this growing trend.

Chair Hart stated that the majority of people in the 105 California cities and counties with plastic bag ordinances have adjusted and/or embraced their respective plastic bag bans.

Report received and filed.

C. Update on Clean Ocean Marketing Campaign

Senior Management Analyst Vondrak narrated a PowerPoint Presentation entitled, "Clean Ocean Outreach, Fiscal Year 2014 Update, dated April 10, 2014." She reviewed current and proposed advertising strategies; advised she is in the process of placing advertising in The Sun Post; displayed web banners and web pages; indicated links for additional information and/or alerts; discussed website visits and click-through statistics; displayed the revised pledge form. In addition, she reviewed the County wide spokesgnome email campaign program and reviewed the landscape rebate statistics.

In response to comments/questions from the Committee Members, Senior Management Analyst Vondrak agreed to forward a recommendation from the Committee that staff work with Laura Ferguson to arrange for a press release to provide information on the program and provide average rebate fund amounts to illustrate the cost effectiveness of the program; advised additional information on the program will be made available when the City's website is updated; noted that staff is monitoring the results of the marketing campaign, and will publish the results closer to the end of the year.

In response to a suggestion from Committee Member Ambrose, Senior Management Analyst Vondrak agreed to offer pledge forms for distribution at Casa Romantica.

Committee Member Smith suggested staff consider designing and issuing an inexpensive decal or gnome sticker for residents' houses or cars that indicate support of the program in return for turning in the signed pledges. Senior Management Analyst Vondrak agreed to research potential and report back.

Committee Member Ambrose suggested that staff consider coordinating and providing pledge forms with its grant awards, summer activities/classes, and community events. Returning a signed pledge form could be considered credit for classes, including those at the high school and through ASB.

10. ITEMS FROM COMMITTEE MEMBERS

Committee Member Smith reported that at the most recent Beaches, Parks and Recreation Commission meeting, the Commission reviewed financial issues associated with the Beaches, Parks, and Recreation Foundation; discussed a Marine Safety Building study to consider relocation due to erosion; invited all to attend a CARE (formerly Tribute Program) Subcommittee meeting at 7:00 p.m. on April 29 in the Ole Hanson Fireside Room at the Community Center.

Committee Member Smith submitted a typewritten list of questions associated with the Poche Beach Action Plan for discussion at a future meeting; requested staff visit and provide input on the existing state of the Poche Pond, which currently resembles a river bisecting the beach; suggested staff consider picking up cobble at Poche Beach at this time because it is currently packed into piles that would be easy to pick up and remove.

Committee Member Ambrose reported that the shredding event was very successful and helpful to the community at large.

Committee Member Brown reported that at their last study session, the Planning Commission heard a presentation on the Local Coastal Program.

Committee Member Nielsen commented that although San Pedro is very forward thinking with its single-use plastic bag ban, he was shocked to receive restaurant leftovers in a Styrofoam container, and suggested the CAC/staff consider writing the City of San Pedro a letter encouraging a Styrofoam ban; commented that monies spent monitoring the Wheeler Reef are in vain as he considers it doubtful that it will ever meet the standard stock of fish required, although the kelp is doing great.

Chair Hart credited Lisa Kerr and the high school program for providing volunteers, high energy, and support at the beach clean ups; invited all to attend Earth Day festivities on April 26; invited the Committee Members to man the City's booth, wear their identification badges, and share information with the public at the event.

Chair Hart thanked Committee Member Smith for providing the list of typewritten questions regarding the Poche Beach Action Plan and stated that he and Senior Management Analyst Vondrak would review the list, contact him for questions or comments.

Senior Management Analyst Vondrak encouraged all to call her to schedule a volunteer shift at the City's booth, or just show up between 10:00 a.m. to 2:00 p.m. In addition, she invited all to attend the H2O for HOAs meeting on April 29 at 8:30 a.m. at the San Juan Capistrano Community Center and noted that all homeowners associations have been invited and many have expressed interest in attending. Chair Hart suggested she contact Lew Avera as he is very involved with Talega Homeowners Association and Committee Member Ambrose agreed to follow up with the homeowners association in her neighborhood.

Subject: Proposed Changes to AB411 Monitoring Program

This information item is presented to update Coastal Advisory Committee members on the San Diego Regional Water Quality Control Board (RWQCB) staff's recommendation for changes to the Ocean Water Quality Monitoring Program in South Orange County. The draft proposal seeks to integrate requirements of NPDES Publicly Owned Treatment Works (POTW) permits, MS4 permits, and AB411 monitoring to increase efficiencies and balance regulatory compliance with public health protection. Information summarized here was provided as part of the staff report¹ for the San Diego Regional Water Quality Control Board April 9, 2014 public workshop.

Background

State law (AB411) requires annual ocean water quality sampling for bacteria at California's public beaches from April 1st through October 31st. While the Orange County Health Care Agency (OCHCA) is responsible for AB411 sampling in Orange County, several other public agencies also monitor ocean water for indicator bacteria as part of other various permit requirements. Monitoring between agencies in the South Orange County area that overlaps both temporally and spatially but remains independent of each other includes: Orange County Public Works in accordance with NPDES Stormwater permit requirements and South Orange County Wastewater Authority (SOCWA) in accordance with their waste discharge requirements.

In December 2012 the RWQCB adopted a Resolution² to revise and update the Monitoring and Assessment framework to improve coordination and effectiveness between agencies. A workgroup of select stakeholders was established to develop recommendations for a proposed monitoring program. This group included: Orange County Public Works, OCHCA, SOCWA, Surfrider, SCCWRP, Sierra Club, City of Dana Point, Heal the Bay and Orange County Coastkeeper. The primary goal of the workgroup was to come up with a program that would answer the question, "Is beach water quality safe for water contact recreation?"

Outcome

The proposed program eliminates duplicative monitoring efforts and goes above and beyond the current State AB411 requirements. Recommendations that came out of the report included consolidating or eliminating sampling stations, revising sampling frequency with respect to the level of impairment, establishing more rigorous triggers for public notification, and implementing investigations when warranted to assess public health risks and/or identify sources.

Sites were recommended for consolidation if two agencies were sampling within 25 yards of another and exhibited a less than 5% exceedance rate for AB411 single sample standards over a five year period from 2005-2009. Only one station in San Clemente, Trafalgar Canyon, was recommended for consolidation. None of the San Clemente stations were recommended for elimination.

Several recommendations for sampling frequencies were proposed. Beach sites with year round recreational use are recommended for increased year-round monitoring while sites with limited access and use were proposed to be discontinued. A matrix was also created which determines frequency of sampling per week based on monitoring results. Areas considered to have an elevated public risk due to frequent exceedances of bacteria standards would be sampled 2-3 times per week depending on their exceedance frequency. At a minimum, beaches would be monitored weekly (Attachment 2).

The workgroup recommended that regardless of sampling station location or time of year, public notification should be provided when certain criteria are met. This would increase the notification to stations that are monitored outside of the current AB411 stations and year round instead of just during the AB411 period required by State law.



Highlights of the Recommended Monitoring Program

- Duplicative sampling and analyzing efforts would be eliminated
- Responsibility of efforts would be shared among Orange County Health Care Agency, Public Works and SOCWA.
- Sample collection, handling and analysis would be consistent
- Reporting, public notifications, additional sampling and investigations would be coordinated more efficiently and effectively
- Public reporting would be more rigorous
- Follow up public health or source investigations would be initiated if warranted

The workshop in April was given to provide information and receive public input. At that time several agencies expressed their support of the proposed unified monitoring program. Permit changes would ultimately be necessary to implement these recommendations.

Subject: Update on Poche Action Plan

This transmittal provides brief highlights of historical activities in the Poche watershed along with an update on current and future projects planned as part of the City of San Clemente's Poche Action Plan.

Background

The Prima Deshecha watershed drains approximately 4,400 acres of land. Virtually all of the urbanized development draining to this watershed is located in the City of San Clemente. The channel itself is concrete lined from the edge of the urbanized development at the end of Camino de Estrella all the way to the outlet at Poche Beach. The upper half of the channel upstream from Calle Nuevo is underground. The portion from Calle Nuevo to Calle Grande Vista includes a dry weather diversion allowing flows from the concrete channel to enter a bioswale that runs through the middle of Shorecliffs golf course. The golf course is required to maintain the bioswale.

In 2002 the Regional Water Quality Control Board issued a directive to the County of Orange and City of San Clemente to address the high bacteria levels found in the channel. Despite source studies and attempts at reducing bacteria levels, samples remained elevated. In 2006 a Clean Beaches Initiative grant was awarded to build a UV treatment plant at the Poche outlet. The plant was built and fully operational by 2010. That same year a comprehensive bacteria source ID study was initiated to investigate sources and determine recommended actions for long term solutions for decreasing bacteria levels in the channel and at the beach. Based on the findings of that study, a Poche Action Plan was created. The plan is a set of actions that staff presented to the City Council as part of the Fiscal Year 2014 Strategic Priority Program. The Council approved the funding needed out of the Clean Ocean Fund to implement the plan. Funding is dedicated for reducing runoff upstream, implementing bird deterrents, investigating a project that would increase the efficiency of the bioswale, investigating the

feasibility of diverting the UV treated outflow to the sewer land outfall pipe, and investigating a project at the Poche pond.

Current Activities

The City's Utilities department already had plans to update its outdated Sewer Master Plan. This plan, which can be viewed by request through the Utilities department, will be a comprehensive update with only one portion being an investigation of the feasibility of diverting the treated outflow to the land outfall pipe. Diversion of the treated water directly to the ocean at Poche is not a possibility due to Regional Water Quality Control Board regulations, however using the land outfall pipe would allow diversion into a system that is already regulated. The RFP for the study is currently being drafted.

The City's Water Conservation and Environmental programs departments are currently collaborating on water conservation efforts to minimize yard runoff entering the storm drain system. These efforts aim to reduce bacteria through minimized transport and biofilm growth. The focus of the project is on irrigation smart controller retrofits and landscape turf removal. Funding will bolster existing incentive programs currently offered by MWDOC and increase marketing efforts to make residents and business owners aware of the opportunities.

Bird deterrent programs are currently in place at the Prima Deshecha Landfill. The falconry program there has been extended through the beginning of June. City staff is in the process of finalizing an agreement to have Adam's Falconry Service return to Poche in June for the remainder of the AB411 sampling season while the landfill's program is suspended.

The Poche UV treatment system started operating on April 15th. It will continue to operate through the AB411 period with the exception of periods of high tides or during maintenance. As of May 5, 2014 the Heal the Bay website has listed the water quality grade at Poche is an A+.

Next Steps

Staff has researched the permitting process and steps required for any type of project at the Poche scour pond. Coastal Commission staff advised the first step would be for the City to update a 2002 Environmental Assessment to determine existing conditions at the site. This assessment was originally performed and written up in a formal report as a requirement for the UV treatment system project. Staff will meet with regulatory agencies to solicit their feedback and determine study requirements in advance of any assessment. Once the Environmental Assessment was updated and information evaluated then a concept plan could be proposed. Several

regulatory agency permits are currently active with respect to both the UV treatment system and management of the outlet for beach access. They are as follows:

The Shorecliff's golf course bioswale project is currently budgeted for FY2016. This would be a reconfiguration of a current system to make it more effective at removing pollutants of concern. This project will need further evaluations and the approval of the golf course to move forward.
