Sealed bids or proposals will be received at the office of the City Clerk, 100 Avenida Presidio, City of San Clemente, California, until **2:00 p.m. on July 9, 2013** and will be publicly opened and read on said day and time in the Council Chambers, Civic Center, 100 Avenida Presidio, San Clemente, California.

The work to be done consists of furnishing all materials, equipment, tools, labor and incidentals as required by the plans, specifications and contract documents for FY 2013 TRAFFIC SIGNAL EQUIPMENT UPGRADES: Battery Backup System, Project No. 12334; LED Traffic Light Replacement, Project No. 12335; Traffic Signal Cabinet & Electrical Services, Project No. 10811 in the City of San Clemente, California.

No bid will be received unless it is made on a proposal form furnished by the City Engineer, Each bid must be accompanied by cash, certified or cashier's check, or bidder's bond, made payable to the City of San Clemente for an amount equal to at least ten percent (10%) of the amount bid, such guarantee to be forfeited should the bidder to whom the contract is awarded fail to enter into the contract.

The contract does call for monthly progress payments based upon the engineer's estimate of the percentage of work completed. The City will retain 5% of each progress payment as security for completion of the balance of the work. At the request and expense of the successful bidder, the City will pay amounts so retained upon compliance with the requirements of Government Code Section 14402 and the provisions of the contract documents pertaining to "substitution of securities."

NOTICE IS FURTHER GIVEN that the Director of the Department of Industrial Relations, in accordance with Section 1770 of the California State Labor Code and in accordance with the terms of the Southern California Master Labor Agreement, has heretofore established a prevailing rate of per diem wages to be paid in the construction of the above entitled work.

The said wage rates are herein referred to and adopted in this Notice as though fully set forth herein and said scale is made a part of this Notice by reference.
