## 7. PUBLIC HEARINGS

# A. Foundation Fitness (232 Avenida Fabricante, Suite 106) – Conditional Use Permit 14-261

Public Hearing to consider an appeal of the Planning Commission's approval of Conditional Use Permit (CUP) 14-261 that would allow a commercial recreation use at 232 Avenida Fabricante, Suite 106.

Associate Planner Wright narrated a PowerPoint presentation entitled "Foundation Fitness CUP 14-261" and responded to Council inquiries. A hard copy of the presentation is on file in the City Clerk's Department.

Mayor Brown opened the Public Hearing.

<u>Peter Scharer</u>, Laguna Beach, voiced concerns regarding the parking requirements for the project due to his belief that the business constitutes a gym; stated that non-compliant vehicles will be towed; urged Council to not approve the Conditional Use Permit for Foundation Fitness.

Steve Yates, San Clemente, owner of the adjoining office condominium, stated that Foundation Fitness is a fitness facility as opposed to a group instruction facility and asserted that the associated parking demand should be considered; opined that there will be ongoing issues with noise associated with the fitness classes; asserted Foundation Fitness will need 27 parking spaces for its clients; noted that each unit is assigned specific parking spaces and alleged that those spaces cannot be legally transferred to another business.

Alfie Gallegos, Foundation Fitness, asserted that their clients use the facility and leave in a short amount of time; stated there is no fitness equipment for clients to use, only group instruction classes, and their primary revenue source is one-on-one personal training; explained they have made appropriate efforts to soundproof the facility.

There being no others wishing to speak, Mayor Brown closed the Public Hearing.

Council requested that Staff provide the applicant with a copy of the City's noise ordinance.

Following discussion, MOTION BY COUNCILMEMBER BAKER, SECOND BY COUNCILMEMBER DONCHAK, CARRIED 5-0, to adopt Resolution No. 14-46 entitled A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA, APPROVING CONDITIONAL USE PERMIT 14-261, FOUNDATION FITNESS, A REQUEST TO ALLOW A COMMERCIAL RECREATION USE, GROUP INSTRUCTION OF FITNESS CLASSES, IN AN INDUSTRIAL BUILDING LOCATED AT 232 AVENIDA FABRICANTE, SUITE 106.

Assistant City Engineer Rebensdorf narrated a PowerPoint presentation entitled "Recycled Water Retrofit Loan Program". A hard copy of the presentation is on file in the City Clerk Department.

MOTION BY COUNCILMEMBER DONCHAK, SECOND BY COUNCILMEMBER BAKER, CARRIED 5-0, to:

- 1. Approve a loan program consistent with the information in the Administrative Report, dated October 21, 2014, and direct staff to work with the City Attorney to formalize loan documents.
- 2. Approve an appropriation of \$400,000 from the Water Operating Fund for the Loan Program.
- 3. Authorize the City Manager to execute the Loan Agreements.

# B. <u>Appointment of City Council Representatives and Key Stakeholders for San Clemente Hospital Sub-Committee</u>

Report from the Assistant City Manager concerning the appointment of City Council representatives and key stakeholders for a San Clemente Hospital Sub-Committee.

Assistant City Manager Sund reviewed the contents of the Administrative Report and responded to Council inquiries.

<u>Duane Cave</u> urged that Jim Leach be appointed as an additional facilitator of the Sub-Committee, noting that he would be an asset.

Mike Clark, San Clemente, stated that he is a retired Chief Strategy Officer for a \$6 billion healthcare system; identified issues that should be assessed by the San Clemente Hospital Sub-Committee and offered to serve as a member of the Sub-Committee.

<u>Dr. Gus Gialamus</u>, San Clemente, spoke in opposition to the closure of San Clemente Hospital's Emergency Room, citing concerns that mortality rates will increase; requested a seat on the Sub-Committee.

Randy Newkirk, San Clemente, stated that a nonprofit organization, such as Saddleback Memorial, qualifies for tax benefits; urged Council and the Sub-Committee to research whether or not a nonprofit organization can change an emergency room to an urgent care facility.

<u>Dr. Steve Cullen</u>, San Clemente, urged Council to appoint Susan Ritschel and Dr. Gialamas to the Sub-Committee; reported on the formation of a non-profit corporation entitled "Save Saddleback San Clemente Hospital" (501(c)3 status pending), and offered to represent the corporation on the Sub-Committee; opined that the South Orange County Economic Coalition is not unbiased and hence its members should not provide facilitator services on the Sub-Committee; suggested that Council request that the hospital defer its proposed closure date to June 2016.

<u>Susan Ritschel</u>, San Clemente, urged Council to appoint Dr. Gialamas and Dr. Cullen to the Sub-Committee to represent the medical community, and offered her services on the Sub-Committee to represent the community at large; asserted that an additional objective for the Sub-Committee should be to evaluate alternatives to the hospital's closure.

<u>Don De La Rosa</u>, San Clemente, voiced concerns regarding the closure of the hospital and spoke highly of the medical care his family received at the hospital; asserted that the closure of the hospital will result in lost jobs and decreased property values; opined that the new construction in South Orange County necessitates more hospitals, not fewer.

<u>Duane Cave</u>, South Orange County Economic Coalition, volunteered to act as a non-biased facilitator for the newly formed Sub-Committee.

Council outlined the following objectives for the San Clemente Hospital Advisory Sub-Committee:

- Evaluation of market forces
- Analysis of alternatives
- Identification of future demand
- Identification of resources necessary to enable the hospital to remain in San Clemente
- Potential Solutions
- Milestones
- Fact Finding
- Community Engagement
