Incident Statistics and Deployment Models

This correspondence is provided to report basic incident statistics, unit call loads, and average hospital transport volume and times. The data contained within has been obtained through the OCFA's Computer Aided Dispatching (CAD) system, and the proprietary Orange County Fire Incident Reporting System (OCFIRS). Additional data is currently being analyzed from other sources and systems to refine and clarify more specific call types, time of day, day of week, etc. That information will be available at a later time.

Current Deployment Model and Anticipated Impacts

- a. One: Status Quo (no changes to current model)
 - i. E50 PAU (3)
 - ii. E60 PME (4)
 - iii. T59 PMT (4)
 - iv. ET60 2 EMT full time
 - v. ET50 2 EMT part time (seasonal)
 - vi. Benefits: Current model. No changes to staffing or deployment. Cost neutral.
 - vii. Impacts: Model requires two units to be dispatched for E50 calls. Impact to coverage and availability for 2nd call due to unit follow-up to ER with ET unit/ambulance. Greater transport and follow-up times due to longer distances, traffic, and ED closure for saturation. Overall reduced regional coverage in an area with existing minimal coverage.
- b. Other possible deployment models are currently in discussion and not available yet.
