VACANCIES ON THE CITY PLANNING COMMISSION, INVESTMENT ADVISORY COMMITTEE AND

COASTAL ADVISORY COMMITTEE

Fiscal Impact:

Summary:

Kathy Ward was recently elected to the San Clemente City Council, and consequently, has submitted the attached letter resigning from the Planning Commission. This resignation creates a vacancy on the Planning Commission for a term to expire June 30, 2015.

Additionally, Les Wells, the Industry Specialist on the Investment Advisory Committee, has resigned from the Committee, thereby creating a vacancy for a term to expire June 30, 2016. A copy of Mr. Wells' resignation letter is attached.

Lastly, a vacancy exists on the Coastal Advisory Committee that was created by the resignation of Ken Nielsen earlier this year. The Coastal Advisory Committee requests that this vacancy (which is for a term to expire June 30, 2015) be filled at this time because another member of the Committee is on extended medical leave and the Committee is experiencing difficulty achieving a quorum for its meetings.

Staff is requesting that Council determine whether it wishes to fill the aforementioned vacancies at this time, or defer filling the vacancies until the annual appointment of Commission and Committee members in June 2015. If Council determines to fill the positions at this time, Staff recommends that Council authorize the City Clerk to advertise the vacancies for a minimum 10-day recruitment period as required by State Law and that Council select a date in January 2015 to interview candidates and make appointments.

Recommended

Action:

STAFF RECOMMENDS THAT the City Council determine whether it wishes to fill the Planning Commission, Coastal Advisory Committee and/or Investment Advisory Committee vacancies at this time, or whether it prefers to defer filling the vacancies until the annual Commission/Committee selection process in June 2015. If Council desires to fill the positions at this time, Staff recommends that Council authorize the City Clerk to advertise the vacancies, and that Council schedule a meeting date in January 2015 to interview candidates and make appointments.
