#### 3. Planning Commission

Council raised the possibility of extending the terms of the Planning Commissioners whose terms are due to expire on June 30, 2015, until such time as the General Plan zoning and Coastal Land Use Plan are complete.

Councilmember Donchak stated that she would not participate in the subject deliberations because the possibility of extending the terms of current Planning Commissioners is not included on the agenda. Councilmember Donchak left the meeting at 7:00 p.m.

Council deferred a decision on the re-appointment issue to enable City Clerk Baade to review the City Code to determine whether Council has the discretion to extend the terms of the current Planning Commissioners.

City Clerk Baade reported that the City Attorney has determined that Council does not have the discretion to extend the terms of the Planning Commission based upon Municipal Code Section 2.32.030 that reads in relevant part as follows: "The terms of office of members of the Planning Commission shall be for two (2) years from July 1st to June 30th of the second following year..."; noted that the Code section also provides that "In the event the City Council does not make the necessary appointments prior to the expiration of the terms, existing members with the expiring terms shall continue to serve as Planning Commissioners until successors are appointed by the City."

Following discussion, Council determined to appoint new Planning Commissioners at this time.
