AMENDMENT TO CONTRACT FOR WEED ABATEMENT

Fiscal Impact: Yes. Funds are available in in the weed abatement budget to cover the contract

amendment, which has a total cost of \$140,400.

Summary:

Weed abatement cost vary from year to year. The 10 year average for the Weed Abatement program is \$136,235.46. The City's current contract was put in place in 2006 and was extended for an additional 5 years in 2012. City Council approved the weed abatement budget for FY 2016 for \$140,400. The proposed amendment reflects an increase to \$140,400 to reflect increased cost associated with additional clearings identified by the Orange County Fire Authority. Every year the Orange County Fire Authority, along with the Weed Abatement Contractor, inspects City property for compliance with the City's fire safety standards. During those inspections, the Orange County Fire Authority identifies additional areas for clearing, in addition to areas normally done. These additional clearings increase the City's weed abatement cost.

Background:

As the Orange County Fire Authority adopts new fire prevention measures, high fire danger areas, and fuel mod standards, the City's weed abatement cost increase. Every year the Orange County Fire Authority identifies City owned canyons, reservoir sites, and property which require clearing. The Orange County Fire Authority inspections are distributed over multiple years, which aids in keeping annual costs down and allows the City to budget appropriately.

#### Recommended

Action:

STAFF RECOMMENDS THAT the City Council: Approve the amendment and authorize the Mayor to execute Contract Amendment by and between the City of San Clemente and E. Stewart and Associates for Weed Abatement, with a "not to exceed"

annual amount of \$140,400.
