# A. Corps of Engineers Sand Project Update

# C. Playground Replacement Program

- Shade is the most important for the comfort of users.

MOTION BY CHAIR PRO TEM BANDARUK, SECOND BY COMMISSIONER MCCORMACK, AND CARRIED 5-0, to 1) concur with the approach to use Engineered Wood Fiber (aka "Fibar") for playground surface in future playground replacement projects; 2) concur with the proposed anticipated timeline of playground replacements as presented; 3) prioritize the inclusion of shade structures for Ages 2-5 playgrounds in future playground replacements; and 4) to pursue more challenging play features when budgets permit.

# D. Consideration to Prohibit Unauthorized Commercial, Organized, or Instructional Activities on Public Beaches, Parks, and Trails

George Blair, Recreation Supervisor, and Pamela Passow, Recreation Manager, summarized the contents of the administrative report regarding a consideration to prohibit unauthorized commercial, organized, or instructional activities on public beaches, parks, and trails, and responded to Commission inquiries.

During discussion, Commissioners, either individually or in agreement commented:

- Commercial use should be clearly defined.
- Listing the activities that require a permit would necessitate more frequent code changes.
- Policy documents should be referenced in the code.
- There is a concern that non-commercial activities would be affected by this change.

During Commission discussion, direction was provided to staff to return at a future meeting with revised verbiage. No action was taken.
