PARKING PROHIBITION ON AVENIDA DE LA ESTRELLA.

Fiscal Impact: None.

Summary: The Planning Commission and staff recommend that the City Council approve prohibiting parking at the location shown on the attached map for Avenida De La Estrella. The purpose of the proposed parking prohibition is to respond to requests and to improve traffic line of sight conditions.

Background: Avenida De La Estrella is a collector street that is 40 feet wide from curb to curb. Parking is permitted on both sides of the street. Staff received a request to establish a no parking zone on Avenida De La Estrella at the alternate driveway ser: ving the 500 block of El Camino Real businesses. The concern is that vehicles parked on the south side of Avenida De La Estrella adjacent to the driveway limit the line of sight for drivers exiting subject parking lot. Based on the site review and additional parking available in the parking lot, staff recommends prohibiting parking on the south side of Avenida De La Estrella at the subject driveway for 20 feet on the west side of the driveway. Prohibiting parking for 20 feet would result in the loss of approximately one parking space, however, the adjacent parking lot includes over 50 parking spaces.

> At its regular September 3, 2014 meeting, the Planning Commission approved staff's recommendation as described herein.

> A notice of intention to consider the installation of the no-parking zone was sent to all adjacent property owners and businesses.

Recommended

Action:

PLANNING COMMISSION AND STAFF RECOMMEND THAT the City Council:

- 1. Approve prohibiting parking on the south side of Avenida De La Estrella, at the alternate driveway serving the 500 block of El Camino Real businesses for 20 feet northwesterly; and
- 2. Adopt Resolution No. , entitled "A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA, AMENDI NG MASTER TRAFFIC RESOLUTION NO. 1846, ESTABLISHING 'NO PARKING AREAS' ON AVENIDA DE LA ESTRELLA."





WHEREAS, the City reviews various locations to improve safety and traffic conditions; and

WHEREAS, the City of San Clemente Planning Commission ("Planning Commission"), at its regular meeting of September 3, 2014 made a recommendation to the City of San Clemente City Council ("City Council") to approve the parking prohibition at the location listed below; and

WHEREAS, the City Council has considered the recommendation by the Planning Commission, and the information provided by City staff and now wishes to implement the recommended parking prohibition.

NOW, THEREFORE, The City Council of the City of San Clemente does hereby resolve as follows:

Section 1. The above recitals are true and correct.

<u>Section 2.</u> Master Traffic Resolution No. 1846, Section 23, entitled "No Parking Areas", is hereby amended by adding the following subsection:

<u>23.d-23a</u> De La Estrella, Avenida, south side, 20 feet west side of the driveway serving the 500 block of El Camino Real businesses at 535 N. El Camino Real.

<u>Section 3</u>. The City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.
