1. Rabies vaccination must be current for the entire licensing period. If your dog has been revaccinated since your last application, a copy of rabies certificate is required so we can update your record.
2. If your dog has been spayed or neutered since your last application, please submit a certificate of spay/neuter signed by a licensed veterinarian and pay the altered fee as shown above.
3. Senior Citizens age 62 or older may apply for a Senior reduced-fee license. Please submit proof of age with your first application.
