## ORDINANCE NO. 1635

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA, AMENDING CHAPTER 2.24 OF THE CODE OF THE CITY OF SAN CLEMENTE RELATING TO THE CITY'S CONFLICT OF INTEREST CODE

WHEREAS, the State of California Political Reform Act of 1974 (Government Code Section 81000, et seq.) requires all public agencies to adopt and promulgate a conflict of interest code; and

WHEREAS, the City of San Clemente has historically adopted its conflict of interest code by ordinance, but desires to adopt the conflict of interest code by resolution from this point forward to facilitate prompt updates to the Code; and

**WHEREAS**, the City of San Clemente desires to replace Chapter 2.24 of the Code of the City of San Clemente with language that refers readers to a stand-alone Conflict of Interest Code that is maintained in the office of the City Clerk.

**NOW, THEREFORE**, the City Council of the City of San Clemente, California, hereby ordains as follows:

Section 1: Chapter 2.24 of the Code of the City of San Clemente is hereby replaced, in its entirety, with the following:

"The City has adopted a Conflict of Interest Code (the "Code") pursuant to the requirements of the Political Reform Act of 1974, Government Code Section 81000 et seq. (the "Act"). The Code sets forth the required provisions for the disclosure of assets and income of designated employees, the disqualification of designated positions from acting where a conflict of interest exists, the list of disclosure categories subject to the disclosure provisions of the Code, and the list of disclosure categories specifying the types of assets and income required to be disclosed by each of the designated positions. The requirements of the Code are in addition to other state and local laws pertaining to conflicts of interest and have the force and effect of law. All officers and employees are directed to refer to the City's Conflict of Interest Code for these specific requirements.

"The Conflict of Interest Code is held in the Office of the City Clerk as the City's Filing Officer/Official."

**Section 2:** The City Clerk shall certify to the passage of this ordinance and cause the same to be published as required by law, and the same shall take effect as provided by law
