FIRST AMENDMENT TO TWO PROFESSIONAL SERVICES AGREEMENTS WITH CIVIC

SOLUTIONS FOR TEMPORARY STAFF AUGMENTATION IN THE PLANNING DIVISION OF THE

COMMUNITY DEVELOPMENT DEPARTMENT.

Fiscal Impact:

Yes, the cost of \$50,472 for two temporary staff is offset by salary savings from two

budgeted but vacant positions in the Planning Division.

Summary:

Two separate Professional Service Agreements have been executed with Civic Solutions for temporary staff. Staff recommends the City Council approve an Amendment to each Agreement for a combined total of an additional \$50,472, and to extend the term of the first contract through February 15, 2017 and the second contract through March 29, 2017. The purpose of the Amendments are to continue providing temporary planning services to assist the Planning Division while the Division is being analyzed by an on-going Matrix Consulting Group study.

Discussion:

On July 13, 2016 and September 22, 2016 the City Manager approved two separate Professional Services Agreements with Civic Solutions to assist the Planning Division with temporary staffing as a result of two vacant planning positions. The temporary staff are assisting in processing minor discretionary permits, plan checks, counter and phone support, and other similar tasks. The cost of the temporary contract planners will be offset by the salary savings of the two vacant positions in the Planning Division.

The Planning Division is currently being evaluated through a study by the Matrix Consulting Group. As a result of this on-going study, two vacant planning positions have not been filled. Without temporary staff support, plan check, permit and entitlement processing, and counter and phone response times will be negatively affected. The proposed \$50,472 amendments allows temporary staff to remain until February 15, 2017 and March 29, 2017. At that time, it is envisioned that the study will be complete and permanent staff will be hired. The first contract amendment will increase the not-to-exceed amount from \$25,000 to \$40,486 and the second contract amendment will increase the not-to-exceed amount from \$25,000 to \$59,986. The combined increase for both contracts will be \$50,472.

Recommended

Action:

STAFF RECOMMENDS THAT the City Council:

- 1. Approve a budget transfer in the amount of \$50,472 from Account No. 001-433-41010-000-00000 (Salaries, Full Time) to Account No. 001-431-43890-000-00000 (Contractual Services); and
- 2. Approve and authorize the mayor to execute a First Amendment with Civic Solutions increasing the Professional Services Agreement for the Planning Technician total compensation from \$25,000 to \$40,486, and extending the contract terms through February 15, 2017, or until services are no longer needed.
- 3. Approve and authorize the mayor to execute a First Amendment with Civic Solutions increasing the Professional Services Agreement for the Part-Time Planning Assistant total compensation from \$25,000 to \$59,986, and extending the contract terms through March 29, 2017, or until services are no longer needed.
