Public Hearing to consider a request for a 533 square foot tasting room use with on-site sale and consumption of a full variety of alcohol associated with a distillery in the Rancho San Clemente Business Park of the Rancho San Clemente Specific Plan at 940 Calle Amanecer, Suite K.
