# 1. SPECIAL PRESENTATIONS

# A. San Clemente Police Services Update

Lt. Dave Moodie, San Clemente Police Services, narrated a PowerPoint presentation which provided an update on Police Services matters and crime statistics. A hard copy of Lt. Moodie's presentation is on file with the City Clerk.

# 2. ORAL COMMUNICATIONS (PART 1)

#### Law Enforcement and Immigrant Rights

<u>Jackie Dooley</u>, San Clemente, spoke on the importance of respecting immigrant rights and opined that law enforcement should not inquire as to a person's immigration status.

<u>Judy Jones</u>, San Clemente, commented on the importance for all individuals to have equal rights regardless of their residency status.

#### Paul Walker Statue

<u>Chad Kroeger</u>, San Clemente, requested the City erect a statue of Paul Walker on the San Clemente Pier, as a unifying figure.

<u>Bodhi Johnson</u>, San Clemente, spoke in support of a Paul Walker statue being erected on the San Clemente Pier.

# **Nuclear Waste at San Onofre Nuclear Generating Station (SONGS)**

<u>Jenifer Massey</u>, San Clemente, voiced concerns with the storage of nuclear waste at SONGS; urged Council to schedule discussions with lawmakers and the Coastal Commission to find an alternative location for the storage of nuclear waste.

<u>Gary Headrick</u>, San Clemente Green, spoke in opposition to nuclear waste being buried at SONGS, possibly for a duration that exceeds the life expectancy of the dry casks; urged Council to submit an amicus curiae brief, prior to the Coastal Commission hearing on April 14, 2017, that urges revocation of the permit that currently allows nuclear waste to be buried at SONGS.

# **Police Services Matrix Study**

Anthony LaFrano, San Clemente, spoke in support of Police Services and Lt. Moodie in particular; suggested that a heroin epidemic exists at the high school and urged Council to take a hard approach to drug and transient issues.

# Cabrillo Playhouse

<u>Sandra Weaver</u>, representing Cabrillo Playhouse, reported on upcoming performances at the Cabrillo Playhouse and noted that she will report back to Council periodically to share entertainment opportunities.

#### Arson/Burglary Victim

<u>Edward McMahon</u>, San Clemente, reported that a transient/addict burglarized and burned his home; voiced concern with the lack of communication from the Sheriff's Department concerning the suspect and noted that he fears for the safety of his family because the suspect threatened his family and may post bail; noted the importance of victims' rights in criminal cases.

- 2. Authorize the submittal of the Draft San Clemente Jurisdictional Runoff Management Plan (JRMP) to the Regional Water Quality Control Board by April 1, 2017.
- 3. Authorize the Public Works Director to accept input from the Coastal Advisory Committee after the draft is available and approve minor corrections to the WQIP and JRMP after a 30-day public review/comment period and annual updates thereafter.

# 1. <u>Contract Contingency Increase – San Luis Rey Park Playground</u> Replacement

Council requested that Administrative Reports include details of the reasoning for significant contract overruns.

Staff is to inform Council whether or not swingsets will be installed at San Luis Rey Park.

- 2. Approve an increase to the contingency from \$7,500 to \$29,900 for the San Luis Rey Park Playground, Project 12724.

MOTION BY COUNCILMEMBER SWARTZ, SECOND BY COUNCILMEMBER HAMM, CARRIED 5-0, to adopt Resolution No. 17-06 entitled A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA, PURSUANT TO SECTIONS 39561 AND 39562 OF THE CALIFORNIA GOVERNMENT CODE DECLARING WEEDS, RUBBISH, REFUSE, AND DIRT UPON STREETS, SIDEWALKS, PARKWAYS, AND PRIVATE PROPERTY TO BE PUBLIC NUISANCES AND PROVIDING FOR THE ABATEMENT THEREOF, with the modification that the Resolution reflect the correct Public Hearing date of May 2, 2017.

# K. <u>SB 687 (Skinner) – Attorney General Authority on Hospital Closures</u> Support Letter

Council urged citizens to learn more about SB 687 and how they can help; pointed out the passage of the bill will not reverse the closure of San Clemente Hospital.

- 1. Support SB 687 (Attorney General Authority on Hospital Closures).
- 2. Authorize the Mayor to execute the letter of support to be submitted to the Senate Committee on Health.

#### 7. PUBLIC HEARINGS

# A. <u>General Plan Consistency for Shorecliffs Senior Housing Site – Specific Plan Amendment 16-361</u>

Public Hearing to consider applicant-initiated amendments to the Forster Ranch Specific Plan. The site is located adjacent to the Shorecliffs Golf Course in an area presently occupied by the club house and driving range at 501 Avenida Vaquero. The site is approximately 500 feet to the west of the Interstate-5 Avenida Vaquero overpass, and 430 feet to the northwest of the intersection of Calle Arco and Avenida Vaquero. There are residences located beyond the golf course to the west, south, and east fronting Calle Grande Vista, Avenida Vaquero, and Calle Arco.

Associate Planner Wright reviewed the contents of the Administrative Report and responded to Council inquiries.

Mayor Ward opened the Public Hearing.

Mark McGuire, attorney representing the property owners, conveyed support for Staff's recommendation and responded to Council inquiry.

There being no others desiring to speak, the Public Hearing was closed.

Following discussion, MOTION BY COUNCILMEMBER DONCHAK, SECOND BY COUNCILMEMBER SWARTZ, CARRIED 5-0, to:

- 1. Find the project is exempt from further review of the California Environmental Quality Act (CEQA) beyond the Centennial General Plan Environmental Impact Report (EIR), State Clearinghouse No. 2013041021, certified on February 13, 2014, pursuant to California Public Resources Code §21083.3.
- 2. Introduce Ordinance No. 1639 entitled AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA, ADOPTING SPECIFIC PLAN AMENDMENT 16-361, AMENDING LAND USE DESIGNATIONS AND STANDARDS FOR A PORTION OF THE FORSTER RANCH SPECIFIC PLAN SECTOR G TO BE CONSISTENT WITH THE CENTENNIAL GENERAL PLAN.

#### 8. UNFINISHED BUSINESS

#### A. Contract Award – San Clemente Summer Trolley

Report from the Interim Public Works Director concerning a contract award for the operation of the San Clemente Summer Trolley.

Interim Public Works Director Bonigut reviewed the contents of the Administrative Report and responded to Council inquiries.

Council requested that the trolley be parked in strategic locations on Mondays through Thursdays as a means of advertising the trolley.

MOTION BY COUNCILMEMBER DONCHAK, SECOND BY COUNCILMEMBER HAMM, CARRIED 5-0, to:

- Confirm white roofs on the trolleys.
- Approve, and authorize the Mayor to execute, Contract C17-11, by and between the City of San Clemente and Professional Parking and Transportation Services, providing for Summer Trolley Transit Operations Services on Fridays through Sundays, in the amount of \$78,336.

# B. Staffing Changes within the Community Development Department

Report from the Assistant City Manager concerning staffing changes within the Community Development Department.

Human Resources Manager Lowe reviewed the contents of the Administrative Report and, along with Interim Code Compliance Supervisor Atamian, responded to Council inquires.

Following discussion, MOTION BY COUNCILMEMBER HAMM, SECOND BY COUNCILMEMBER SWARTZ, CARRIED 5-0, to:

- Adopt Resolution No. 17-07 entitled A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA, ADOPTING A REVISED SALARY SCHEDULE AND NEW CLASSIFICATIONS AND AMENDING RESOLUTION NO. 16-66 AND ANY OTHER RESOLUTIONS IN CONFLICT THEREWITH.
- Approve the job descriptions for Code Compliance Manager, Code Compliance Technician and Community Development Technician I.

#### 9. **NEW BUSINESS**

# A. Consideration of Letter Concerning the Potential 241 Toll Road Extension Option Number 9

Report from the Interim Public Works Director concerning the possibility of submitting a letter to the appropriate transportation agencies and regional stakeholders concerning the potential 241 Toll Road Extension Option Number 9.

Interim Public Works Director Bonigut reviewed the contents of the Administrative Report and displayed a map that depicted routes that the TCA is considering for the toll road extension.

Mark McGuire, San Clemente, explained that he opposes an arterial that would follow the route delineated in Option 8 (La Pata/Cristianitos Road extension) because of its negative impact to sensitive habitat areas; commended Council for actively opposing any toll road alignment through San Clemente; recommended that Council support a toll road extension that ends at Cow Camp Road or Ortega Highway.

<u>Dan Bane</u>, San Clemente, urged Council to support Option 8 (La Pata/Cristianitos Road extension) and Option 15 (which would extend the 241 around San Clemente to an I-5 connection at Cristianitos Road); recommended that Council be aggressive in letters relating to the Environmental Impact Report; urged that Best, Best & Krieger investigate options available to the City; requested that property in San Clemente that is already owned by the TCA be identified to provide insight as to the alignment that the TCA intends to pursue.

Pete Van Nuys, San Clemente, noted that the beltway (i.e., the connection of the 5, 241 and 73) would alleviate traffic in Mission Viejo and San Juan Capistrano and is the best option available.

Gary Headrick, San Clemente Green, noted that San Clemente Green would publicly advocate against a toll road extension through San Clemente and spoke in support of the use of simulations as a communication tool to educate the public.

Following discussion, MOTION BY COUNCILMEMBER DONCHAK, SECOND BY COUNCILMEMBER HAMM, CARRIED 5-0, to:

- 1. Authorize Staff to prepare a letter to the Transportation Corridor Agency that will begin, and end, with emphasis on San Clemente's opposition to any toll road alignment through the City. The letter is to promote the development of an arterial solution that could include routes indicated as Option 8 (La Pata/Cristianitos Road extension), Option 9 (east/west connection between 73 and 241 toll roads), and the Crown Valley Parkway extension. Copies of the letter are to be provided to Assemblymembers, State Senators, County Supervisor, OCTA and Caltrans.
- Direct Staff to develop a plan for the individual alignments to be considered separately, with the understanding that simulations would be developed and that residents affected by each alignment would be notified so that they could speak at the appropriate Council meeting.

Council requested that updates on the toll road extension issue be provided at each Council meeting for the next six months.

(1) Consideration of Forming a Committee with the Cities of San Juan Capistrano and Dana Point to Discuss Issues of Mutual Concern

MOTION BY COUNCILMEMBER SWARTZ, SECOND BY COUNCILMEMBER HAMM, CARRIED 5-0, to extend an invitation to the Cities of San Juan Capistrano and Dana Point to meet with representatives from the City of San Clemente on a monthly basis for a one-year trial period. Attendees from each City will consist of the Mayor, City Manager or Assistant City Manager, and possibly one Councilmember (to be determined by each city). The purpose of the meetings is to exchange ideas and synergize on issues of mutual concern. A summary from each meeting is to be provided to Council via memorandum.

# **Support Local Businesses**

Councilmember Swartz encouraged residents to support San Clemente businesses by shopping locally.

# Orange County Transportation Authority Report (OCTA)

Councilmember Donchak provided an update on OCTA-funded signal synchronization projects throughout the City.

### Retired Senior Volunteer Patrol (RSVP)

Councilmember Donchak requested that Staff research the possibility of opening the RSVP program to persons under 55 years of age.

# San Onofre Nuclear Generating Station (SONGS)

Councilmember Donchak referenced the Interim Consolidated Storage Act and Price-Anderson Nuclear Industries Indemnity Act and requested that Best, Best & Krieger research the possibility of redefining the definition of a "Consent-Based Community" to include involuntary hosts, such as San Clemente, so that San Clemente can receive the associated benefits (financial, insurance, etc.). Council further suggested that the City also seek to receive the financial benefits of being an Interim Consolidated Storage site, including retroactive compensation for the past 40+ years of storage of nuclear material at SONGS.

#### Sign Ordinance

Councilmember Donchak requested the Sign Ordinance be agendized to enable the temporary signage to remain in place at the Outlet mall while the permanent sign process is in motion.

MOTION BY COUNCILMEMBER HAMM, SECOND BY MAYOR PRO TEM BROWN, CARRIED 3-2 (COUNCILMEMBERS DONCHAK AND SWARTZ VOTING NOE), to **not** agendize the possibility of initiating a change to the Sign Ordinance as it relates to temporary signage at the Outlet mall.

#### **Transportation Corridor Agency**

Mayor Ward reported that CalTrans independently initiated a settlement agreement to not build a road in the toll road avoidance area.
