CITY COUNCIL ACCEPTANCE AND NOTICE OF COMPLETION FOR THE STREET REHABILITATION AND SLURRY SEAL FOR AVENIDA PICO (COURTYARDS TO CAMINO LA

PEDRIZA) PROJECT No. 16346.

Fiscal Impact: None. The total project cost including engineering, inspection, administration and construction is \$321,000 which is within the approved budget of \$371,000 in the FY

2016 Gas Tax Fund.

Summary:

All American Asphalt has completed the construction contract on time, within budget and staff recommends Council acceptance:

Discussion:

The contract was awarded by the City Council on August 2, 2016. This project included applying a slurry seal and restriping Avenida Pico from the Courtyards to Camino La Pedriza (see map in Attachment 1). A few small distressed pavement areas were cold milled and repayed as needed with two inches of asphalt concrete.

The new striping better balances the street by reducing vehicular travel lanes from 12 to 15 feet down to 11 feet and using the extra width to establish buffered bike lanes along the majority of the street segment. The striping plan was designed in conformance with the California Manual on Uniform Traffic Control Devices and approved by the City Council on June 13, 2016.

Additionally, surplus contingency funds were used to crack seal streets listed on Attachment 2. The crack sealing helps preserve existing streets and prepares some of the streets for future slurry sealing projects.

The Notice of Completion is provide in Attachment 3 and a detailed summary of the total expenditures is provided below:

- 3. Authorize the City Clerk to release the Payment Bond 35 days from the recordation of the Notice of Completion upon verification with the Engineering Division that no liens have been levied against the Contractor, All American Asphalt.; and
- 4. Authorize the City Clerk to release the Performance Bond upon receipt of a Warranty Bond in the amount of 25% of the construction cost.


