Mayor Ward presented a Proclamation to Wayne Greenleaf, San Clemente Veterans of Foreign Wars, declaring May 27-28, 2017 as Buddy Poppy Days.

B. <u>Presentation of Proclamation – National Beach Safety Week</u>

Mayor Ward presented a Proclamation to Ian Burton, Marine Safety Officer, proclaiming May 22-29, 2017, as National Beach Safety Week.

C. <u>City Fiscal Reports</u>

Assistant City Manager Sund narrated a PowerPoint presentation entitled "FY 2017 3RD Quarter Financial Report as of March 31, 2017". A hard copy of Mr. Sund's presentation is on file with the City Clerk.

2. ORAL COMMUNICATIONS (PART 1)

Short Term Lodging Units

Sherif Amanious, San Clemente, stated that sober living residences assist persons with mental health issues; urged Council to repeal Ordinances 1616 and 1622.

<u>Richard Noble</u>, Palm Springs, read a document (a copy of which is on file with the City Clerk) that promoted sober residences and urged the repeal of Ordinances 1616 and 1622.

<u>Christine Williams</u> reported on her experiences as a case manager in a sober living facility and working with persons with mental illness.

Bahrum Moghadam, San Clemente, urged Council to repeal Ordinances 1616 and 1622 and opined that treatment facilities help patients receive the help they need.

Bernard Oakley, Tustin, stated Ordinances 1616 and 1622 are hateful in nature; urged Council to repeal the Ordinances.

<u>Jacob Bennett</u>, Vista, urged Council to repeal Ordinances 1616 and 1622, noting that treatment facilities save lives.

<u>Thomas Whitten</u>, San Clemente, stated that while there is a need for sober living facilities, Ordinances 1616 and 1622 were designed to limit the proliferation of short-term rental units and protect permanent residents; asserted that businesses should not operate in residential neighborhoods; urged Council to leave Ordinances 1616 and 1622 in place.

MOTION BY COUNCILMEMBER DONCHAK, SECOND BY COUNCILMEMBER SWARTZ, CARRIED 4-0 (MAYOR PRO TEM BROWN ABSENT), to approve, and authorize the City Manager to execute, Contract C17-19, by and between the City of San Clemente and Calpine Energy Solution, providing for electricity for a two-year term, for an amount not to exceed \$34 per Kilo-watt hour.

ITEMS REMOVED FROM THE CONSENT CALENDAR FOR DISCUSSION

L. <u>Lease Agreement – Bait and Tackle Concession at the City Municipal Pier</u>

Assistant City Manager Sund reviewed the contents of the Administrative Report and responded to Council inquiries.

<u>Scott Shipley</u>, San Clemente, provided an overview of his business model; stated that if the lease agreement is approved by Council, he can open almost immediately; responded to Council inquiries.

MOTION BY COUNCILMEMBER SWARTZ, SECOND BY COUNCILMEMBER HAMM, CARRIED 4-0 (MAYOR PRO TEM BROWN ABSENT), to approve, and authorize the City Manager to execute, Contract C17-18, a Lease Agreement, by and between the City of San Clemente and Scott Shipley, providing for the operation of the Bait & Tackle concession on the Municipal Pier with the following modifications to the agreement:

- 1. Agreement is to make it clear that the agreement is with Scott Shipley as an individual, and not a joint venture as originally proposed.
- 2. The hours of operation are to be specified.
- 3. The date of opening is to be specified.
- 4. A proviso is to be added to indicate that the lease is not transferrable without Council authorization.
- 5. Seasons and off-seasons are to be delineated.
- 6. The services to be provided are to be itemized.
- 7. Agreement is to specify that the sale of fish and tackle merchandise is minor in nature.
- 8. Agreement is to specify that fishing instructions are not to be provided.
- 9. Agreement is to specify that catering services/deliveries are prohibited.

M. <u>Initiation of Zoning Amendment – Regulation of Murals on Private</u> Property

In response to Council inquiry, City Planner Gregg reported that the Zoning Amendment to regulate murals on private property will be submitted to the Planning Commission and City Council this year.

MOTION BY COUNCILMEMBER HAMM, SECOND BY COUNCILMEMBER DONCHAK, CARRIED 4-0 (MAYOR PRO TEM BROWN ABSENT), to initiate a Zoning Amendment to address regulation of murals on private property.

O. <u>Lease Agreement – North Beach Concession</u>

Assistant City Manager Sund reviewed the contents of the Administrative Report and responded to Council inquiries.

During the course of discussion concerning signage opportunities to attract beach trail users to the concession, Staff noted that A-Frame signs are not permitted in the public right-of-way. Council expressed willingness to consider ideas from the concessionaire to erect signage to attract beach trail users.

MOTION BY COUNCILMEMBER HAMM, SECOND BY COUNCILMEMBER DONCHAK, CARRIED 4-0 (MAYOR PRO TEM BROWN ABSENT), to approve, and authorize the City Manager to execute, Contract C17-20, a Lease Agreement, by and between the City of San Clemente and Sand and Sea Restaurant Group, providing for operation of the North Beach concession, with the following conditions:

- 1. The scope of services in the Agreement is to specify that the concessionaire is responsible for maintaining clean premises surrounding the concession.
- 2. The concessionaire is not to be granted special events permits beyond that allowed by others.
- 3. Operations are to be limited to food services. No rentals are to be offered.
- 4. A proviso is to be added to indicate that the lease is not transferrable without Council authorization.
- 5. Hours of operation are to be specified.

7. PUBLIC HEARINGS

A. Quade Residence - 404 South La Esperanza (Appeal of Minor Architectural Permit 16-370, and Minor Exception Permit 16-371)

Public Hearing to consider an appeal of the Zoning Administrator's approval of a 1,176 square foot second-story addition to a legal nonconforming residence, located at 404 South La Esperanza.

Associate Planner Jones reviewed the contents of the Administrative Report and responded to Council inquiries.

Mayor Ward opened the Public Hearing.

<u>Erik Quade</u>, Applicant, narrated a PowerPoint presentation entitled "404 S. La Esperanza", and responded to Council inquiries. A hard copy of Mr. Quade's presentation is on file with the City Clerk.

<u>David Buettner</u>, Appellant, narrated a presentation entitled "Appeal of approval of Architectural Permits 16-370 & 16-371 for 404 South La Esperanza"; voiced concern that the project will negatively impact privacy from his rear yard. A hard copy of Mr. Buettner's presentation is on file with the City Clerk.

<u>Keith Howington</u>, San Clemente, opined that the letter provided to Council by the Applicant contains incorrect information concerning average home sizes in the neighborhood; asserted that many neighbors do not support the proposed addition to the Quade residence; urged Council to deny the request.

<u>Susan Howington</u>, San Clemente, urged Council to consider neighbors' concerns and oppose the project.

<u>Patricia Lamont</u>, San Clemente, stated that she lives directly above the Quade residence and is concerned that the proposed project will negatively affect her view; acknowledged that the City does not protect private views, but requested that the City not approve the 2" waiver that would enable her view to be obstructed; urged Council to deny Minor Exception Permit 16-371.

Ann Buettner, San Clemente, stated her property line is 7' from the Quade deck wall; opined that the proposed addition will negatively impact property values and her privacy; voiced concern that the project would threaten slope stability.

Thomas Whiten, San Clemente, suggested that the subject project will negatively impact the quality of life for surrounding neighbors; urged Council to oppose the application.

There being no others desiring to speak, the Public Hearing was closed.

Following deliberations, MOTION BY COUNCILMEMBER HAMM, SECOND BY COUNCILMEMBER DONCHAK, CARRIED 4-0 (MAYOR PRO TEM BROWN ABSENT), to:

- 1. Adopt Resolution No. 17-12 entitled A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, APPROVING MINOR ARCHITECTURAL PERMIT 16-370, QUADE RESIDENCE, A REQUEST TO CONSIDER AN EXPANSION OF A LEGAL NONCONFORMING RESIDENCE LOCATED AT 404 SOUTH LA ESPERANZA, with the notation that the Applicant has the discretion to relocate the upper deck.
- 2. Deny Minor Exception Permit 16-371. By virtue of this action, the second story of the structure must comply with current setback requirements (and not follow the existing residence's legal nonconforming setback deficiency of 2" on the south side of the structure and 1" on the north side of the structure).

A. <u>Contract Award – Visual Simulations of Potential Toll Road</u> Alignments

Report from the Deputy Public Works Director concerning a contract award providing for visual simulations of potential Toll Road alignments.

Deputy Public Works Director Bonigut reviewed the contents of the Administrative Report and responded to Council inquiries.

<u>Don Kunze</u>, San Clemente, urged Council to oppose the proposed contract for toll road photo simulations.

Brenda Miller, San Clemente, stated residents should be encouraged to utilize local train service to reduce the demand for additional roads; urged Council to approve the contract for photo simulations.

<u>Josh Hershman</u>, San Clemente, stated that he was part of a group in Long Grove, Illinois that stopped a toll road from being constructed through their town and offered his assistance in the City's efforts; urged Council to not approve the contract for photo simulations because the simulations could help the Transportation Corridor Agency.

<u>Eric Liss</u>, San Clemente, offered his assistance in providing 3-D simulations of the proposed toll road alignments as well as apps to be attached to social media.

During the course of discussion, Council provided direction as follows: 1) opined that six images, at a cost of \$27,500, is not acceptable; 2) Requested information concerning the timeline involved in creating the simulations; 3) Expressed interest in how the proposed alignments would connect to high-impact points, especially around the freeway; 4) Determined that the issue should be continued until after the TCA conducts its mobility workshop at Saddleback College on June 5, 2017 and to also enable Mayor Pro Tem Brown to participate in the deliberations.
