CONSTRUCTION CONTRACT AWARD TO DOUG MARTIN CONTRACTING COMPANY INC., FOR

FY 2018 SLURRY SEAL PROGRAM, CITY PROJECT No. 28302.

Fiscal Impact: Yes. The estimated project cost of \$286,000 exceeds the FY 2018 General Fund project budget of \$250,000. A transfer appropriation in the amount of \$36,000 from the Street Improvement Fund to General Fund Account No. 001-416-45720-28302 is

required to complete this project.

Summary:

Staff recommends that the City Council approve a construction contract with Doug Martin Contracting Company Inc., in an amount not to exceed \$237,898,72. The purpose of the contract is to apply protective slurry to City streets shown on Attachment 1, which need minor resurfacing maintenance.

Discussion:

Bids were opened on August 9, 2017 and the results are presented in the attached bidder's listing (Attachment 2). The lowest responsive bidder is Doug Martin Contracting Company Inc., from La Habra California, with a bid amount of \$237,906.57.

The bid form contained twelve multiplication errors that totaled a net bid decrease of \$7.85. Extending the unit bid prices per the Public Contract Code and summing the total. results in an actual grand total bid price of \$237,898.72. Based on the low bid, the total estimated project cost is \$286,000 as summarized below, which exceeds the approved budget of \$250,000.

As required by City Policy and State Law, the Contractor will be required to provide performance and payment bonds simultaneously with execution of the construction contract. A warranty bond will also be required prior to City Council acceptance of the project.

Per City Council direction in 2012, staff is considering the deletion of existing centerlines during this maintenance project unless a majority of residents who respond on a specific street are opposed to the change or if staff believes that existing centerlines (or portions thereof) are needed for safety. A letter will be sent requesting residents' preference regarding centerlines on Calle Guadalajara, from Calle Frontera to Calle Vallarta. The street centerlines will not be replaced unless a majority of the surveyed resident responses favor centerline replacement.

Staff is also proposing to implement Class II bicycle lanes on Calle Saluda if the community and City Council support the concept. Staff will be completing a neighborhood meeting on the subject the week of August 28, 2017 and including the item on the September 20, 2017 Planning Commission agenda. Staff will be returning to City Council on October 3, 2017 if the Planning Commission recommends the proposed change.

STAFF RECOMMENDS THAT the City Council:

- 1. Approve the plans and specifications for the FY 2018 Slurry Seal Program, Project No. 28302;
- 2. Authorize the Mayor to execute a contract by and between the City of San Clemente and Doug Martin Contracting Company Inc., in the amount of \$237,898.72 for the FY 2018 Slurry Seal Program; and
- 3. Approve a transfer in the amount of \$36,000 from the fund balance of the Street Improvement Fund to General Fund Account No. 001-416-45720-28302.


