RESOLUTION OF THE BOARD OF DIRECTORS FOR BROADMOOR SAN CLEMENTE COMMUNITY ASSOCIATION IN OPPOSITION TO

THE ORIENTATION OF PROPOSED TOLL ROAD ROUTES THROUGH SAN CLEMENTE

WHEREAS, Broadmoor San Clemente Community Association is a nonprofit corporation, incorporated under the laws of the State of California for the purpose of exercising the Association's duties and responsibilities;

WHEREAS, The undersigned five (5) Directors are the duly elected members of the Board of Directors for the Association;

WHEREAS, The Association is made up of 201 Members, whose properties are located off Avenida Pico, within the City of San Clemente, County of Orange, State of California;

WHEREAS, The members of the Board of Directors for the Association have reviewed the proposed orientation(s) for the TCA Toll Road Expansion in and around San Clemente;

WHEREAS, All of the members of the Board of Directors, both individually and collectively, unanimously feel that a toll road expansion through any part of San Clemente, particularly an orientation through Avenida Pico (known as Orientation #14 of the proposed TCA Toll Road Expansion), will have a deleterious effect on the entire Association, and will have a serious, negative impact on the entire community of San Clemente.

BE IT RESOLVED THAT, The members of the Association's Board of Directors hereby support the City of San Clemente in its "NO TOLL ROAD THROUGH SAN CLEMENTE" position; and,

BE IT FURTHER RESOLVED THAT, The members of the Association's Board of Directors, in particular opposes any orientation of the Toll Road that would bisect the democratically designated and approved Pico Valley Area, i.e. Orientation #14 of the proposed TCA Toll Road Expansion that would bisect the City of San Clemente, along Avenida Pico.
