A. 111 Avenida Vista Montana – Conditional Use Permit No. 16-027, Site Plan Permit No. 16-018, Architectural Permit No. 16-026 and Master Sign Program Permit No. 16-062 (Life Time Fitness) (Vazquez)

Public Hearing to consider a request for the redevelopment/renovation of the existing Rancho San Clemente (RSC) Tennis & Fitness Club into a new 45,000-square-foot, single-story clubhouse with terraced, below-grade facilities, a restaurant, spa, locker rooms, child care facilities, exercise rooms, pro shop, and associated

administrative/office spaces. A new swimming pool, shaded outdoor gathering space, and expanded parking area are also proposed at 111 Avenida Vista Montana within the Rancho San Clemente Specific Plan (RSCSP) zoning designation. The site's legal description is Lot F of Tract 12124. The Assessor's Parcel Number is 688-101-03.

Staff recommends that it be determined that a Mitigated Negative Declaration (MND) is appropriate. This determination has been made according to the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the City of San Clemente's CEQA Implementation Procedures.
