Public Hearing to consider a City-initiated amendment of Municipal Code (SCMC) Title 17 "Zoning" (Zoning Amendment 17-204), Section 17.24.070 containing provisions for density bonuses and other incentives for

affordable housing projects and senior citizen housing developments in accordance with prior State law. This amendment will update the SCMC to comply with current State law pursuant to Assembly Bills (AB) 744, 2222, 2556, 2442, and AB 1934, as codified in Government Code Sections 65915-65915.7.
