

NOTICE TO VOTERS OF DATE AFTER WHICH NO ARGUMENTS FOR OR AGAINST A CITY MEASURE MAY BE SUBMITTED TO THE CITY CLERK

NOTICE IS GIVEN that a General Municipal Election is to be held in the City of San Clemente, California on November 6, 2018, at which there will be submitted to the voters the following measure:



NOTICE IS FURTHER GIVEN THAT PURSUANT TO Article 4, Chapter 3, Division 9 of the Elections Code of the State of California, for measures placed on the ballot by petition (which is the case with the subject measure), the persons filing an initiative petition may file a written argument in favor of the ordinance, and members of the legislative body who are authorized by the body, may submit an argument against the ordinance. The written arguments may not exceed 300 words in length.

NOTICE IS FURTHER GIVEN that the City Clerk has fixed **September 12, 2016**, during normal office hours, as posted, as the date after which no arguments for or against the measure may be submitted to the clerk for printing and distribution to the voters as provided in Article 4. Arguments shall be submitted to the City Clerk, accompanied by the printed name(s) and signature(s) of the author(s) submitting it, or if submitted on behalf of an organization, the name of the organization, and the printed name and signature of at least one of its principal officers who is the author of the argument, in the City Clerk's Office, located at 100 Avenida Presidio, San Clemente, California. Arguments may be changed or withdrawn until and including the date fixed by the City Clerk.

NOTICE IS FURTHER GIVEN that the City Council has determined that rebuttals to the direct arguments, not to exceed 250 words in length, may be filed with the clerk, accompanied by the printed name(s) and signature(s) of the author(s) submitting it, or if submitted on behalf of an organization, the name of the organization, and the printed name and signature of at least one of its principal officers who is the author of the argument, not more than 10 days after the final date for filing direct arguments (i.e., **September 21, 2016** during normal office hours).

NOTICE IS FURTHER GIVEN that any resolution, impartial analysis, direct argument, or rebuttal argument filed under the authority of the elections code will be available for public examination in the clerk's office for not less than 10 calendar days from the deadline for the filing of the direct arguments, impartial analysis, and rebuttal arguments.
