PARTNERSHIP AGREEMENT WITH SAN CLEMENTE PUBLIC LIBRARY FOR SUMMER READING

PROGRAM.

Fiscal Impact: Yes. A loss of revenue equaling approximately \$1,350 in Community Center rental

revenue, annually.

Summary:

The San Clemente Public Library, operated by the County of Orange, is requesting a waiver for its summer reading program that includes the waiver of rental fees and

deposit associated with the Community Center Auditorium.

Background:

A Partnership Policy was adopted by City Council to encourage and promote activities. facility rentals, and special events/programs on a year around basis that provide valuable cultural, recreational, and civic benefits to residents, visitors, and businesses of San Clemente. The process to become a Partner requires a minimum of two fee waiver requests for the activity, facility rental, or special event within a two-year period. Over the course of the two-year period, the City reviews the success of the program before formalizing a Partnership. The primary criterion to quality for a fee waiver under the policy, it that the organization is a non-profit civic or social organization, and all revenue generated by the event largely benefits the residents, visitors, and businesses of San Clemente.

The San Clemente Public Library (SCPL) branch has hosted a summer reading program for the past 25 years at the Community Center, at no cost to SCPL. In 2016. formally SCPL requested a fee waiver for its annual summer activity. On January 17, 2017, City Council unanimously approved the SCPL request to waive the rental fees for the Community Center Auditorium.

Discussion:

SCPL is requesting a fee waiver to hold its annual summer reading program at the Community Center. As a well-established program/facility rental, the program attracts approximately 1,000 attendees throughout the summer, with roughly 250-350 attendees weekly. Because this activity has occurred for many years at no cost to SCPL and the program is a great benefit for the community, staff recommends the Commission approve a partnership agreement between the City and SCPL for all future summer reading program facility rentals.

SCPL will be responsible for coordinating the weekly activities, including marketing. providing staff and volunteers, supplies, equipment, and entertainment for each activity.

Recommended

Action:

STAFF RECOMMEND THAT the Beaches, Parks and Recreation Commission recommend the City Council approve a partnership agreement with the San Clemente Public Library for its annual Summer Reading Program, waiving the rental fees and deposit for the use of the Community Center Auditorium.

Fee Waiver: San Clemente Library Summer Reading Program

This letter serves as a request for a fee waiver for the use of the Community Room Auditorium for the San Clemente Library Summer Reading Program.

Summer Reading programs serve to prevent "summer slide", the tendency for students to lose some of the achievement gains they made during the previous school year.

The San Clemente Library offers a well-established summer reading program that encourages almost 1,000 kids, teens, and adults to read over the summer.

Educational, fun enrichment activities throughout the summer are an important feature of the programs. The library has held weekly programs in the adjacent Community Room Auditorium for approximately ten years. Attendance at these shows draw an average of 200 attendees weekly. Historically, the City has charged neither the library, County or Friends of the Library for use of the Auditorium.

In the spirit of community benefit and inter-agency cooperation, I would ask that the City waive all fees in the total amount of \$1,450.00 (\$1,350,00 for rental fees [6 weeks, @75/hr.] and \$100 refundable deposit) for use of the Auditorium. This would cover 6 free weekly shows on Thursday mornings for the enjoyment of all who would like to attend.
