#### **CITY PROPERTIES – NO FLY ZONE AREAS**

Pursuant to San Clemente Municipal Code Section 8.82.050(E) [Reasonable Time, Place, Manner], "No person shall takeoff, land, or operate a UA within 500 feet of any county or city owned jails, holding facilities, law enforcement facility, or within 500 feet of any designated publicly owned building chosen by the city. The designation of publicly-owned buildings applicable to this subsection shall be at the discretion of the City Manager. The addresses of all properties described in this subsection shall be available for viewing by the public at the City Clerk's Office and listed on the City of San Clemente website, on a page dedicated to information related to [unmanned aircraft ("UA")], or 'drone,' operations and requirements." The following buildings have been designated for inclusion on the "no-fly zone" list of publicly-owned buildings described above.
