CITY COUNCIL ACCEPTANCE AND NOTICE OF COMPLETION FOR STREET REHABILITATION

FOR SOUTH EL CAMINO REAL, PROJECT No. 14326.

Fiscal Impact:

Yes. The project was completed within the approved budget of \$993,000 in the FY

2014 Gas Tax Fund.

Summary:

R.J. Noble Company has completed the construction contract on time, within budget

and staff recommends City Council acceptance.

Background:

On December 16, 2014, the City Council authorized staff to submit a grant application with the Orange County Transportation Authority (OCTA) for federal funding through the 2014 Arterial Pavement Management Program. The grant for this project requires a 53.3% match which is included in the project budget. On January 12, 2015 the OCTA Board approved a grant for the South El Camino Rehabilitation in the amount of \$395,043. The cooperative agreement with OCTA for the South El Camino Rehabilitation was approved on November 18, 2015. The project had to be postponed several years due to Caltrans' lengthy grant review and funding approval process.

The contract was awarded by the City Council on April 4, 2017. This project rehabilitated approximately 2,200 feet of South El Camino Real from Avenida Medocino to East Avenida San Juan. The project included cold milling the full street width to remove the asphalt over the underlying concrete areas. Failed pavement was reconstructed. The street was overlaid with a full width one-inch leveling course followed by a two-inch rubberized asphalt cap. Following the pavement construction the street was restriped in the existing configuration. In addition to the pavement rehabilitation, curbs ramps were retrofitted or reconstructed as necessary to meet current ADA standards. Where required, curb ramps and adjoining sidewalk was replaced with Ole Hanson replica tile. Deteriorated curb and gutters will be replaced in kind.

A detailed summary of the total expenditures is provided below:

- Accept the Street Rehabilitation for South El Camino Real, Project No. 14326 from R.J. Noble Company;
- Authorize the Mayor to execute and the City Clerk to record the Notice of Completion for Street Rehabilitation for South El Camino Real, Project No. 14326;
- 3. Authorize the City Clerk to release the Payment Bond 35 days from the recordation of the Notice of Completion upon verification with the Engineering Division that no liens have been levied against the Contractor, R.J. Noble Company; and
- 4. Authorize the City Clerk to release the Performance Bond upon receipt of a Warranty Bond in the amount of 25% of the construction cost.


