A. <u>Site Plan Permit 17-375/Minor Conditional Use Permit 17-376/Architectural Permit 17-377 – 225 Avenida Fabricante – Glaukos Corp Parking Lot (Morones)</u>

A request to consider a 70-stall parking lot with access gates on a vacant lot. The site is located at 225 Avenida Fabricante, in the Industrial Park of

the Rancho San Clemente Specific Plan. The site's legal description is Lot 9 of Tract 14609. The Assessor's Parcel Number is 690-661-09.

Staff recommends that the project be found categorically exempt from the requirements of the California Environmental Quality Act (CEQA) pursuant to State CEQA Guidelines Section 15303 Class 3 because the project consists of the construction of a new parking lot with a limited number of parking stalls and the small new equipment of an entry/exit gate. The lot was previously mass graded, is adjacent to development, and does not contain environmentally sensitive areas.
