## REGULAR BUSINESS MEETING CONVENED

The Regular Business Meeting of May 1, 2018 convened at 6:00 p.m., with all members present, except Councilmember Swartz and Mayor Pro Tem Hamm.

## **INVOCATION**

Holland Davis, Senior Pastor - Calvary Chapel San Clemente, gave the invocation.

#### **PLEDGE OF ALLEGIANCE**

Mayor Brown led the Pledge of Allegiance.

#### 1. **SPECIAL PRESENTATIONS**

#### A. Toll Road Update

Councilmember Ward reported on her attendance at a Budget Committee meeting for the San Joaquin Hills and Foothill Eastern Transportation Corridors; noted that the TCA wants to study managed lanes on the I-5 from San Clemente to the San Diego County border; explained that some Board members expressed an interest in modifying the Joint Powers Agreement to expand the TCA's powers inasmuch as the I-5 is currently beyond the TCA's authority; related that members stated that they don't believe the toll roads should ever be free.

#### B. Planning Commission Update

Don Brown, Planning Commission Chair, reported on Planning Commission activities.

# 2. ORAL COMMUNICATIONS (PART 1)

# Cabrillo Playhouse

<u>Sandra Weaver</u>, Cabrillo Playhouse, spoke on the value of the Playhouse to the community and noted that *Vanya and Sonja and Marsha and Spike* is currently playing; expressed a desire for Cabrillo Playhouse updates to appear on Council agendas.

# **City Executive Management**

Jim Smetona, San Clemente, stated that he worked for the City of San Clemente for 35 years, but took an early retirement due to the new City executive management; opined that working conditions have deteriorated and requested that the results of the employee satisfaction survey be released.

#### **Sunshine City**

<u>Brad Malamud</u>, San Clemente, urged that Council agendize the possibility of San Clemente becoming a sunshine city, whereby all City records are made public; stated that the cost associated with fulfilling public records requests would be reduced.

#### SB 54 (California Values Act)

<u>Bonnie Robb</u>, San Clemente, urged Council to protect public safety by adopting a resolution opposing SB 54 (California Values Act).

Gene James, San Clemente, urged Council to take a stance on the sanctuary state issue, noting that federal law trumps State law; urged Council to add deputies to protect public safety.

<u>Jackson Hinkle</u>, San Clemente, urged Council to not oppose SB 54 inasmuch as the City has more significant issues to address; spoke in opposition to mass deportations.

#### San Onofre Nuclear Generating Station

Ray Lutz, Citizens Oversight, noted that Citizens Oversight and the California Coastal Commission entered into a settlement agreement with regard to Citizens Oversight's lawsuit concerning the Commission's issuance of a permit to store nuclear waste at SONGS; urged Council to adopt a resolution that supports the settlement agreement and the relocation of nuclear waste from SONGS to a safer location; requested that Council endorse Citizens Oversight's HELMS proposal.

# **Community Choice Energy**

Monica Perez, San Clemente, urged Council to consider Community Choice Energy to reduce utility bills and foster quicker movement toward the use of renewable energy resources.

Terry Otsuki Kwa, San Clemente, spoke in support of Community Choice Energy and identified its benefits.

# **Homeless Encampments (Fire Danger)**

<u>Sean Conway</u>, San Clemente, voiced concern with homeless encampments and the associated fire dangers.

#### Pier Pride Fundraisers

Mikii Rathmann, Pier Pride, reviewed Pier Pride's 2018 fundraisers to help preserve the pier; explained that Pier Pride's goal is to create an endowment.

#### **Cannabis**

Angela Conrad, San Clemente, opined that controlled cannabis can fit in San Clemente; pointed out that the tax dollars from cannabis sales would benefit the City.

# B(1). Planning Commission Regular Meeting Minutes of April 18, 2018

Jim Ruehlin, San Clemente, stated that he is a member of the Planning Commission, but is speaking on behalf of himself; referenced Item 8-C on the Planning Commission Regular Meeting minutes of April 18, 2018 relating to Short Term Lodging Units (STLUs) - ZA 17-392; urged that Council refer the STLU ordinance back to the Planning Commission due to his belief that the Commission's findings were based on inaccurate information.

Mayor Brown stated that he intends to recuse himself from deliberations on the STLU issue because his wife is in the real estate industry.

City Attorney Smith pointed out that Mayor Brown's recusal would leave Council without a quorum and recommended that the Planning Commission minutes be continued.

MOTION BY COUNCILMEMBER DONCHAK, SECOND BY COUNCILMEMBER WARD, CARRIED 3-0 (COUNCILMEMBER SWARTZ AND MAYOR PRO TEM HAMM ABSENT) to continue the Planning Commission Regular Meeting minutes of April 18, 2018 to the Adjourned Regular Council meeting of May 9, 2018, which will take place at 4:00 p.m. in the Council Chambers.

#### 7. PUBLIC HEARINGS

# A. <u>Consideration of California Coastal Commission Modified and Approved Local Coastal Program Comprehensive Land Use Plan Update</u>

Public Hearing to consider the California Coastal Commission (CCC)- approved City of San Clemente Comprehensive Land Use Plan Update. The CCC approved the LUP with suggested modifications at the CCC public hearing on February 8, 2018. The City of San Clemente is considering the suggested modifications from the CCC to the LUP and must act to accept or reject the modifications within 6 months of the CCC approval.

Council noted that the Public Hearing on the subject item will be continued to the Council meeting of June 12, 2018; noted that persons may speak this evening on an informational basis, but pointed out that the formal Public Hearing will be opened on June 12, 2018; urged citizens interested in having their comments included in the official record to either address Council on June 12, 2018 or submit their comments in writing.

Bree Hughes, San Clemente, expressed opposition to changing Cyprus Cove's private beach access to public use; noted that such a conversion will negatively affect her quality of life and property value.

MOTION BY COUNCILMEMBER DONCHAK, SECOND BY COUNCILMEMBER WARD, CARRIED 3-0 (COUNCILMEMBER SWARTZ AND MAYOR PRO TEM HAMM ABSENT), to continue the Public Hearing on the California Coastal Commission (CCC) Modified and Approved Local Coastal Program (LCP) Comprehensive Land Use Plan (LUP) Update to the Council meeting of June 12, 2018.

# B. <u>Code Amendments - Phase 2 Comprehensive Code Updates (Zoning Amendments 17-412 and 18-090)</u>

Public Hearing to consider a City-initiated amendment of Municipal Code (SCMC) Title 17 "Zoning" (Zoning Amendments 17-412 and 18-090). These Zoning Amendments are City-initiated to amend the San Clemente Municipal Code (SCMC) Title 17, Zoning, for Phase 2 of the comprehensive Zoning Code updates. These updates generally include incorporating remaining zoning updates for General Plan land use consistency and Housing Element Action Plan updates. It is anticipated that the entire comprehensive update will be completed in multiple phases.

Contract Planner Stonich narrated a PowerPoint presentation entitled "Phase 2 Zoning Code Update", a hard copy of which is on file with the City Clerk; distributed an errata sheet for Page 23 of the proposed Ordinance for ZA 17-423, which varied from the proposed Ordinance contained in the Administrative Report in that the following sentence was omitted from Paragraph E: "Also, standalone residential uses are allowed."

Mayor Brown opened and closed the Public Hearing, there being no one desiring to speak to this issue.

During the course of discussion, Council noted that Mixed Use was envisioned to enable people to live where they work and requested data as to whether Mixed Use is, in fact, performing as originally anticipated. It was agreed that Staff will provide Council with occupancy rates for Mixed Use across all zones and will also look at some of the newer projects to determine if they were built as envisioned by the General Plan Advisory Committee (GPAC) and the General Plan.

MOTION BY COUNCILMEMBER WARD, SECOND BY COUNCILMEMBER DONCHAK, CARRIED 3-0 (COUNCILMEMBER SWARTZ AND MAYOR PRO TEM HAMM ABSENT), to:

- 1. Determine that the project is exempt from further review of the California Environmental Quality Act (CEQA). Pursuant to State CEQA Guidelines Section 15162, the project is exempt because it is within the scope of Final Environmental Impact Report (EIR), State Clearinghouse No. 2013041021, certified for the Centennial General Plan on February 13, 2014, and the program EIR adequately describes the project. The project could have no new effects and no new mitigations are required.
- Introduce Ordinance No. 1652 entitled AN ORDINANCE OF THE 2. CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA, MAKING CEQA FINDINGS AND FOR A CITY-INITIATED AMENDMENT (ZA 17-412) TO THE CITY OF SAN CLEMENTE ZONING, TO CODE 17, MUNICIPAL TITLE CONSISTENCY BETWEEN THOSE DOCUMENTS AND THE ADOPTED CENTENNIAL GENERAL PLAN, FOR PHASE 2 OF CODE PURSUANT ZONING THE COMPREHENSIVE GOVERNMENT CODE SECTION 65860, including the errata sheet (which eliminated the sentence "Also, standalone residential uses are allowed" from Page 23, Paragraph E).
- 3. Introduce Ordinance No. 1653 entitled AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA, MAKING CEQA FINDINGS AND FOR A CITY-INITIATED AMENDMENT (ZA 18-090) OF THE CITY OF SAN CLEMENTE MUNICIPAL CODE SECTION 17.28.300 FOR TEMPORARY FENCING.

## C. <u>Code Amendment - Regulation of Short-Term Lodging Units (STLU)</u> <u>Zoning Ordinance Amendment 17-392</u>

Public Hearing to consider a City-initiated amendment of San Clemente Municipal Code Title 17, the Zoning Ordinance, (Zoning Amendment 17-392) regarding regulation of Short-Term Lodging Units (STLUs). The City Council will be considering changes to the existing STLU regulations including, but not limited to, the expansion of the STLU overlay area, existing development standard requirements and operating procedures. On April 18, 2018 the Planning Commission voted (4-1) to concur with Staff and recommend approval of the proposed amendment to the City Council.

City Attorney Smith advised that Mayor Brown will recuse himself from this agenda item because his wife is a real estate professional involved in residential home sales and some aspects of the subject item relate to homes within 500' of the Brown residence; explained that Mayor Brown's recusal will leave Council without a quorum, adding that Mayor Brown can vote to continue the item; stated that speakers can address the issue of the continuance, but if they wish to address the substance of the item, they should speak at the Public Hearing that will take place on May 9, 2018 at 4:00 p.m. in the Council Chambers.

Robert Peters, San Clemente, opined that inadequate public notification of the proposal was provided; urged Council to provide enhanced notification about the continued Public Hearing.

Brad Den Dulk, San Clemente, agreed with the proposed continuance.

Jim Ruehlin, San Clemente, stated that he is a member of the Planning Commission, but is speaking on his own behalf; stated that residents of Buena Vista and the Montalvo/Lobeiro loop have not received direct communication about the hearing; voiced concern that the May 9, 2018 Council meeting is planned to be held at 4:00 p.m., which will hinder attendance; spoke in support of enhanced notification and rescheduling of the May 9, 2018 meeting to evening hours.

<u>Tracey Engelking</u>, San Clemente, questioned the necessity for Mayor Brown's recusal since the proposal affects all residents of San Clemente.

<u>Hugh Limebrook</u>, San Clemente, voiced concern that inadequate notification of the subject hearing was provided.

MOTION BY COUNCILMEMBER DONCHAK, SECOND BY COUNCILMEMBER WARD, CARRIED 3-0 (COUNCILMEMBER SWARTZ AND MAYOR PRO TEM HAMM ABSENT), to continue the Public Hearing concerning regulation of Short Term Lodging Units (ZA 17-392), due to lack of quorum, to the Council meeting of May 9, 2018 at 4:00 p.m. in the Council Chambers.

Council requested that Staff provide enhanced notification of the May 9, 2018 Public Hearing (e.g., newspapers, social media, email communications, posting on City website, and property postings at the Montalvo/Lobeiro loop and North Beach.)

#### **MEETING RECESSED**

Council recessed at 7:42 p.m. and reconvened at 7:58 p.m., with all members present, except Councilmember Swartz and Mayor Pro Tem Hamm.

#### D. Weed Abatement Program 2018

Public Hearing to consider all objections or protests, if any, to the proposed abatement of weeds, rubbish, refuse and dirt upon streets, sidewalks, parkways and private property within the City of San Clemente.

Code Compliance Manager Atamian reviewed the contents of the Administrative Report.

Mayor Brown opened and closed the Public Hearing, there being no one desiring to speak to this issue.

SECOND BY BY COUNCILMEMBER DONCHAK. MOTION COUNCILMEMBER WARD, CARRIED 3-0 (COUNCILMEMBER SWARTZ AND MAYOR PRO TEM HAMM ABSENT), to adopt Resolution No. 18-15 entitled A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN THE DIRECTOR **ORDERING** CLEMENTE. CALIFORNIA, COMMUNITY DEVELOPMENT TO ABATE THE NUISANCES BY HAVING WEEDS, RUBBISH, REFUSE, AND DIRT REMOVED FROM VACANT PROPERTIES AND UNOCCUPIED, DEVELOPED PROPERTIES WITHIN THE CITY.

# A. <u>Additional San Clemente Trolley Service for the 2018 Summer Operating Season</u>

Report from the Public Works Director/City Engineer concerning the possibility of authorizing additional San Clemente trolley service for the 2018 summer operating season.

Public Works Director/City Engineer Bonigut narrated a PowerPoint presentation entitled "San Clemente Trolley Summer 2018 Service Options", which is on file with the City Clerk, and responded to Council inquiries.

Mikii Rathmann, San Clemente, stated that both the Downtown Business Association and the Chamber of Commerce request that trolley service be extended to Thursdays, preferably through Labor Day; urged that Council expand service to S. El Camino Real.

MOTION BY COUNCILMEMBER DONCHAK, SECOND BY COUNCILMEMBER WARD, CARRIED 3-0 (COUNCILMEMBER SWARTZ AND MAYOR PRO TEM HAMM ABSENT), to:

- 1. Approve, and authorize the Mayor to execute, Amendment No. 3 to Contract C17-11, by and between the City of San Clemente and Professional Parking and Transportation Services, providing for Wednesday and Thursday trolley service from May 31 through September 3, 2018, in an amount not to exceed \$52,000.
- 2. Approve a supplemental appropriation in the amount of \$50,000 from the Air Quality Fund undesignated fund balance to Account 019-819-45300-000-00000.
- 3. Approve a supplemental appropriation in the amount of \$14,000 from the Council Contingency to Account 019-819-45300-000-00000.
- 4. Defer the conversation concerning the destination label change on the trolley vehicles until a master plan is developed that addresses how communications/advertising may or may not be included on trolley vehicles.

City Attorney Smith reviewed the contents of the Administrative Report and responded to Council inquiries; requested that the following modifications be made to the proposed Ordinance: 1) That Page 3, Section 1.22.030, be modified to reference "ten business days", as opposed to "ten working days", to be consistent with wording throughout the ordinance; and 2) That Page 2, Section 1.22.020, be amended to change reference to "administrative hearing or appeal" with "administrative hearing or administrative appeal"; responded to Council inquiries.

Brad Malamud, San Clemente, asserted that the proposed ordinance is a disservice to the citizens of San Clemente; voiced concern that the ordinance does not establish a cap on fees and suggested that the proposal is an attack on appeals filed by the Outlets at San Clemente; urged that the Ordinance be amended to provide appellants the option to bypass appeals and take an issue directly to court.

MOTION BY COUNCILMEMBER WARD, SECOND BY COUNCILMEMBER DONCHAK, CARRIED 3-0 (COUNCILMEMBER SWARTZ AND MAYOR PRO TEM HAMM ABSENT), to:

- 1. Introduce Ordinance No. 1655 entitled AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA, ADDING A NEW CHAPTER 1.22 TO TITLE 1 OF THE SAN CLEMENTE MUNICIPAL CODE RELATING TO FEES FOR ADMINISTRATIVE HEARINGS AND APPEALS AND AMENDING SECTIONS 1.20.080 AND 1.20.090 OF CHAPTER 1.20 OF TITLE 1 OF THE MUNICIPAL CODE RELATING TO JUDICIAL REVIEW OF ADMINISTRATIVE CITATIONS, with the following modifications: 1) That Page 3, Section 1.22.030, be modified to reference "ten business days", as opposed to "ten working days"; and 2) That Page 2, Section 1.22.020, be amended to change reference to "administrative hearing or appeal" with "administrative hearing or administrative appeal".
- 2. Direct Staff to notice a Public Hearing for a future Council meeting to establish reasonable appeal fees.

### B. Recreation Sports Partnership Application - Elite Soccer League

Report from the Beaches, Parks and Recreation Department concerning a Recreation Sports Partnership application by Elite Soccer League.

Recreation Manager Thomas reviewed the contents of the Administrative Report.

Michael Affleck, Laguna Hills, speaking on behalf of Elite Soccer, reviewed Elite Soccer's history in San Clemente; stated that Elite Soccer would be able to offer more scholarships to San Clemente youth if it is granted Platinum sponsorship; opined that AYSO is able to offer additional programs because of its sponsorship level.

MOTION BY COUNCILMEMBER DONCHAK, SECOND BY COUNCILMEMBER WARD, CARRIED 3-0 (COUNCILMEMBER SWARTZ AND MAYOR PRO TEM HAMM ABSENT), to approve, and authorize the Mayor to execute, an Agreement (Contract No. C18-19), by and between the City of San Clemente and Elite Soccer, providing for Gold Partnership status for a one-year period. (*Note: This Agreement is retroactive to November 2017.*)

Council directed Staff to revisit the sponsorship issue on a global scale (i.e., including both AYSO and Elite Soccer) in November 2018 when Elite Soccer's agreement is due to expire.

DONCHAK, SECOND BY BY COUNCILMEMBER **MOTION** (COUNCILMEMBERS COUNCILMEMBER WARD. CARRIED 3-0 SWARTZ AND MAYOR PRO TEM HAMM ABSENT), to continue the Public Hearing concerning Regulation of Short-Term Lodging Units as they relate to administrative fines, transient occupancy tax, and solid waste collection, to the Council meeting of May 9, 2018 that will take place at 4:00 p.m. in the Council Chambers.

## SB 54 (California Values Act)

<u>Judy Jones</u>, San Clemente, speaking on behalf of the League of Women Voters, stated that the League will be sending a letter to Council urging that it not act on SB 54; explained that the League opposes the deportation of unauthorized immigrants that have no history of criminal activity.

#### D. **Council Members**

(1) <u>Consideration of City Position on Federal Bill HR 3929 -</u> <u>Stranded Nuclear Waste Accountability Act of 2017</u>

Public Works Director/City Engineer Bonigut reviewed the contents of the Administrative Report.

Ray Lutz, Citizens Oversight, stated that it is difficult to know what HR 3929 could mean for San Clemente, but it is worth pursuing the funds; urged that Council form a standing committee relative to the SONGS issue; urged that Council adopt a resolution that supports relocation of the nuclear waste from SONGS and acknowledges that the City incurs costs relating to spent fuel and associated risks.

<u>Laurie Headrick</u>, San Clemente Green, stated that it appears that HR 3929 would not benefit San Clemente and stressed that even if the bill can help San Clemente, it should not be interpreted as consent; identified possible uses for funding.

<u>Gary Headrick</u>, San Clemente Green, stated that greater clarity relative to the bill is needed; urged that the City pursue all funding sources to improve public safety.

<u>Jackson Hinkle</u>, San Clemente, noted that HR 3929 could provide significant funding for emergency planning; commented that the best way to prevent an emergency is to ensure that problems cannot happen in the first place; voiced concern that HR 3053 (Nuclear Waste Policy Amendments Act of 2017) could have devastating results.

Council provided direction to Staff as follows:

- Contact Congressman Issa's office to determine why he is not co-sponsoring the current version of HR 3929, versus last year's failed bill, and encourage his co-sponsorship. Desired modifications to the bill include: 1) Better definition of "jurisdiction", and 2) Identification of allowable usage of funds should they become available, as well as the amount of the funds, and what the City would need to do.
- 2. Identify lobbyist(s) knowledgeable in the energy industry and meet with them to discuss the City's needs and the various pieces of legislation that are in progress and report back with a proposed plan of action as to whether or not a lobbyist

should be utilized. If a lobbyist is deemed to be beneficial, provide a scope of work and associated cost.

3. Determine the deadline for the City to take a position on HR 3929.

## (2) Orange County Fire Authority Report (OCFA) - Mayor Brown

Mayor Brown reported that Brian Fennessy assumed his duties as the OCFA's Fire Chief on April 16, 2018.

#### (3) Medal of Valor Event

Councilmember Ward reported on her attendance at the 30th Annual Orange County Sheriff's Department Medal of Valor event; reviewed awards presented, which included recognition of six off-duty Sheriff Deputies that assisted during the active-shooter situation in Las Vegas.
