Staff recommendation: the Beaches, Parks and Recreation Commission recommend the City Council approve a partnership agreement with PierPride Foundation for a 5-year term with (3) possible 5-year extensions.

B. Use Of Bicycles and Electric Bicycles on Beach and Beach Trail.

Staff recommendation: the Beaches, Parks and Recreation Commission

- 1) Provide comment regarding the use of bicycles on the beach and the Beach Trail; and
- 2) Confirm the Beaches, Parks and Recreation Commission April 10, 2018 recommendation to ban the use of electric bicycles on the beach and the Beach Trail; and
- 3) Direct staff to draft a Municipal Code amendment and/or resolution to Chapter 12.32 of the San Clemente Municipal Code for City Council approval, if appropriate based on discussion.

C. San Luis Rey Park Master Plan Amendment to Add Pickleball Use – Second Review.

A report by Samantha Thomas, Recreation Manager, regarding a possible park master plan amendment to San Luis Rey Park to allow for the addition of pickleball striping on tennis courts.

Staff recommendation: the Beaches, Parks and Recreation Commission recommend the City Council approve a master plan amendment to San Luis Rey Park to add pickleball as a planned use of the park by approving the addition of pickleball striping in addition to tennis striping to two existing tennis courts.
