Jayson Schmitt, Chandler Asset Management representative, and Mark Taylor reviewed the third quarter investment report with the committee and answered questions raised by committee members. ### (4) <u>EVALUATE ADDING AN ADDITIONAL CHANDLER INVESTMENT</u> <u>STRATEGY</u>

Jayson Schmitt presented the committee with a report titled "Portfolio Comparisons" and reviews various Chandler Investment strategies, (as noted in

the report) with the committee. The committee discussed impacts of the various strategies. Steve Swartz moved to direct Chandler and staff to provide a City liquidity analysis and a transition plan for moving up to \$25,000,000 (within the City's \$75,000,000 portfolio manager by Chandler) over a twelve month period to Chandler's short-term bond strategy. Seconded by Art Carter. Approved 6-0

#### (5) <u>ANNUAL REVIEW OF BROKER/DEALERS</u>

City Treasurer, Mark Taylor, presented the four broker dealer questionnaires submitted to the City and the committee discussed. Art Carter recused during discussion of Wells Fargo. Scott Mahl moved to maintain Raymond James, Wells Fargo, RBC Capital, as Broker-Dealer's for the City, seconded by Cathie D'Itri. Approved 5-0. Art Carter Abstained.
