#### 4. PUBLIC HEARINGS

### A. <u>1505 South Ola Vista – Minor Architectural Permit 18-093/Minor Exception Permit 18-136 – Henneforth Residence (Morones)</u>

A request to consider an 854 square foot addition to an existing nonconforming, single-family residence, with the continuation of a 3-foot 6-inch nonconforming side yard setback. The proposed project is an addition to an existing structure that will not increase the floor area by 50-percent or more.

Staff recommends that the project be found categorically exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15301 of the CEQA Guidelines as a Class 1 exemption.

### B. 641 Camino De Los Mares, D110 – Minor Conditional Use Permit 18-461 – Thai Dara 2 Beer and Wine (Webber)

A request to allow the sale and on-site consumption of beer and wine at an existing restaurant in a commercial center.

Staff recommends that the project be found categorically exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15301 of the CEQA Guidelines as a Class 1 exemption.

## C. <u>210 Calle Lasuen – Minor Architectural Permit 18-455/Minor Exception</u> <u>Permit 18-456 – Franzen Remodel</u> (Crockett)

A request to allow an addition to a nonconforming residence, including a minor exception to allow a second floor deck to encroach we should specify how far, such "two feet" or "eighteen inches" into the front yard setback.

Staff recommends that the project be found categorically exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15301, Class 1, Existing Facilities.
