CITY COUNCIL ACCEPTANCE AND NOTICE OF COMPLETION FOR CAMINO DEL RIO REHABILITATION & INTERSECTION IMPROVEMENTS, PROJECT NOS. 16347 AND 16350 AND

CAMINO DE LOS MARES REHABILITATION & SLURRY SEAL, PROJECT NO. 17331.

Fiscal Impact: Yes. The project was completed within the approved budget of \$2,250,000.

Summary:

All American Asphalt has completed the construction contract within budget and staff

recommends Council acceptance.

Background:

The contract was awarded by the City Council on December 6, 2016, to construct intersection improvements on Camino Del Rio at Camino De Los Mares and at Calle Sarmentoso, as well as Camino Del Rio pavement rehabilitation, and Camino De Los Mares pavement rehabilitation and slurry seal. The project location map is provided in Attachment 1.

A detailed summary of the total expenditures is provided below:

Planning, Project Management and Design	\$259,000
Construction	1,505,576
Construction Management and Inspection (rounded up)	67,000
Project Contingency	0
Estimated Total Project Cost (rounded up)	\$1,832,000

The project was substantially complete by November 13, 2017, however, the contractor needed to address several items prior to the City accepting the improvements as complete including repairing failing slurry seal areas and repairing brick pavers that had repeatedly settled.

Recommended

Action:

STAFF RECOMMENDS THAT the City Council:

- 1. Accept the Camino Del Rio Rehabilitation & Intersection Improvements, Project Nos. 16347 and 16350 and Camino De Los Mares Rehabilitation & Slurry Seal. Project No. 17331, from All American Asphalt;
- 2. Authorize the Mayor to execute and the City Clerk to record the Notice of Completion for the Camino Del Rio Rehabilitation & Intersection Improvements,

Project Nos. 16347 and 16350 and Camino De Los Mares Rehabilitation & Slurry Seal, Project No. 17331;

- 3. Authorize the City Clerk to release the Payment Bond 35 days from the recordation of the Notice of Completion upon verification with the Engineering Division that no liens have been levied against the Contractor, All American Asphalt; and
- 4. Authorize the City Clerk to release the Performance Bond upon receipt of a Warranty Bond in the amount of 25% of the construction cost.


