Subject: *CONTRACT AWARD FOR INSTALLATION LABOR FOR BEACH TRAIL FENCE NORTH OF THE PIER.*

Fiscal Impact: Yes. The total project cost of \$47,250 is funded within the approved FY 2019 Major Maintenance operating budget.

Summary: Staff recommends approval of a construction contract with Valley Cities / Gonzalez Fence in the amount of \$45,000 and a five percent contingency of \$2,250 for a total contract amount of \$47,250 providing for installation labor for Beach Trail Fence north of the Pier.

Discussion: The City Council approved funding for this replacement project as part of the FY 2019 Major Maintenance operating budget. The scope of work involves replacement of 1,200 feet of fencing along the Beach Trail.

The project was advertised for public bidding on the City's Planet Bids system. Six bids were received and opened by the City Clerk on November 29, 2018, as noted below. The low bid of \$45,000 was submitted by Valley Cities / Gonzales Fence of Norco, California. Staff recommends including a five percent contingency to allow for administrative approval of any change orders related to unforeseen conditions for a total estimated project cost of \$47,250.

Six bids were received from the following companies:

Valley Cities/Gonzalez Fence	\$45,000.00
Red Hawk Services	\$46,008.00
AB Fence Company	\$55,500.00

As required by City Policy and State Law, the Contractor will be required to provide performance and payment bonds simultaneously with execution of the construction contract. A warranty bond will also be required prior to City Council acceptance of the project. Valley Cities / Gonzales Fence bid is on file at the City Clerk's office.

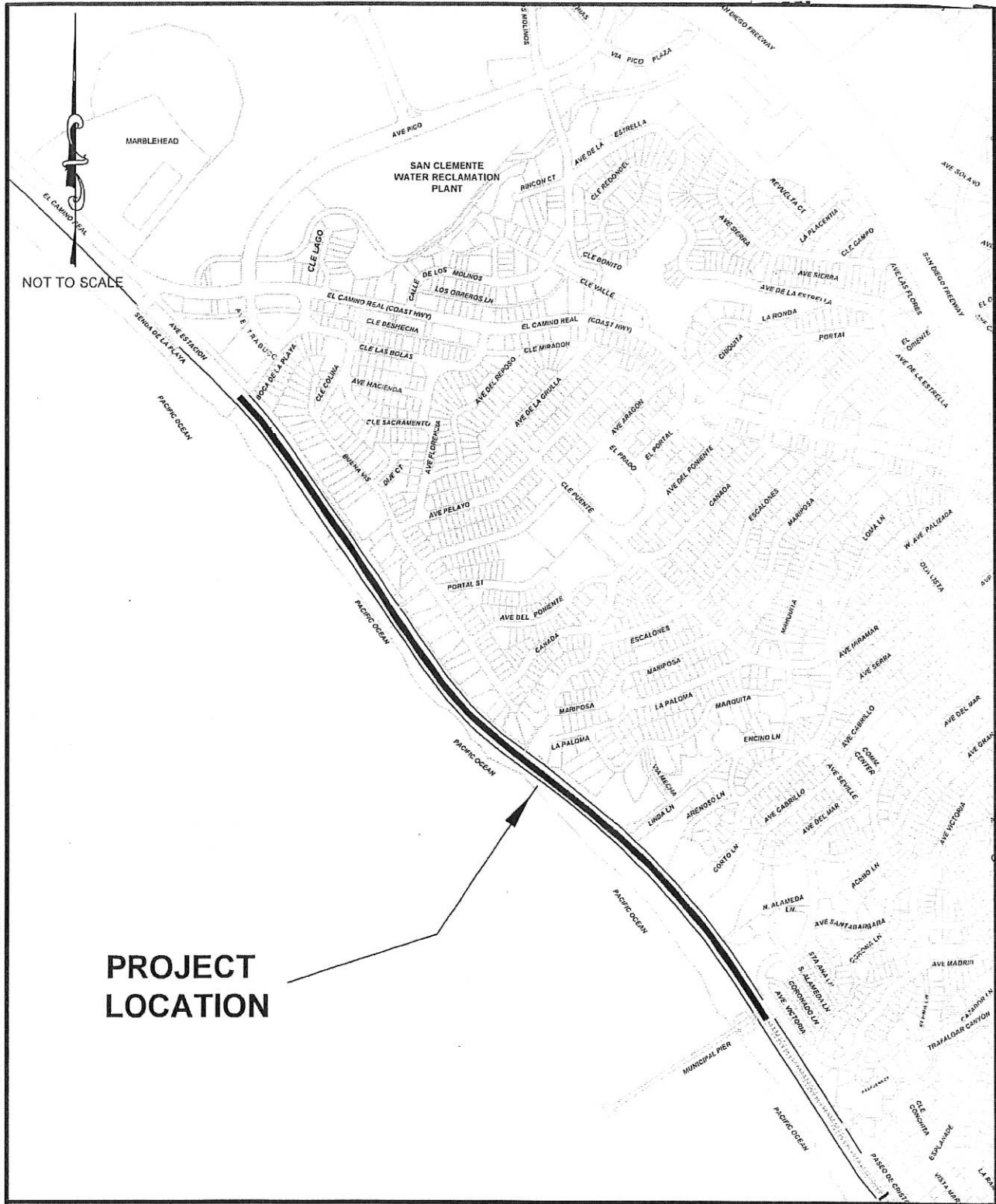
Recommended

Action: 1) Approve and authorize the City Manager to execute, Contract _____, by and between the City of San Clemente and Valley Cities / Gonzalez Fence, in the amount of \$45,000, providing labor of Beach Trail Fence repair north of the Pier; and 2) Approve a 5% project contingency to allow for administrative approval of unforeseen change orders, thereby approving a total project cost of \$47,250.
