REGULAR BUSINESS MEETING CONVENED

The City Council Business Meeting of December 18, 2018 convened at 6:04 p.m., with all members present.

INVOCATION

Don Kappauf, Chaplain, Orange County Sheriff-Coroner Department, gave the invocation.

PLEDGE OF ALLEGIANCE

Mayor Pro Tem Bane led the Pledge of Allegiance.

1. SPECIAL PRESENTATIONS

A. Holiday Vocal Performance - 5th Grade Choir Students

Fifth grade choir students from Truman Benedict, Marblehead, Vista del Mar, Concordia and Las Palmas Elementary Schools, under the direction of Choir Teacher Sharon Evans, provided a holiday vocal performance.

B. Toll Road Update

City Attorney Smith reported that the City Council, at its meeting of November 20, 2018, directed BBK to initiate an amendment to the City's complaint challenging the consulting contracts that were recently awarded by the TCA and the TCA's actions that exceed its legislative authority; provided a status report on the filing of the amended complaint.

C. City Fiscal Reports

Assistant City Manager Sund and Deputy Administrative Services Director Vincent reviewed the Fiscal State of the City for the period ending June 30, 2018, Fiscal Year 2018 4th Quarter Financial Report, and FY 2018 1st Quarter Financial Report. A hard copy of the PowerPoint entitled "Fiscal State of the City" is on file with the City Clerk.

2. ORAL COMMUNICATIONS (PART 1)

Citizens Climate Lobby

<u>Larry Kramer</u>, San Juan Capistrano, reported that he is the President of the local chapter of Citizens Climate Lobby and identified the purposes of the organization; urged Council to consider climate change when making decisions that affect climate.

<u>Jenifer Massey</u>, San Clemente, encouraged Councilmembers to attend meetings of the Citizens Climate Lobby.

San Clemente Hospital Closure

<u>Gus Gialamas</u>, San Clemente, thanked Council for its continued efforts to bring a hospital to San Clemente; noted that the lack of a hospital results in increased mortality rates.

<u>Debbie Weddle</u>, San Clemente, former employee at San Clemente Hospital, spoke on the need for a hospital in San Clemente to save lives; pointed out that some patients cannot survive a 15-minute drive to Mission Hospital, noting that community hospitals can stabilize patients before they are transferred to a trauma center.

<u>Steve Cullen</u>, San Clemente, reviewed the history of the closure of San Clemente Hospital; voiced concern that Memorial Care is currently suing the City for \$42 million because the City allegedly devalued its property through a rezone, despite the fact that it received six offers to purchase the property; urged Council to continue to seek a new hospital for San Clemente.

Michael Clark, San Clemente, spoke on the need for quality emergency services in the City and expressed willingness to help the Council in this endeavor.

<u>Terri Plunkett</u>, San Clemente, voiced concern that the closure of San Clemente Hospital has negatively affected public health and safety; reported that surrounding hospitals are short-staffed and that patients are subjected to long wait times.

<u>Carol Wilson</u>, Capistrano Beach, reported that she recently went to Mission Hospital in Laguna Beach due to illness, but the hospital was filled to capacity; spoke on the need for a local hospital.

<u>Kirk Tobiassen</u>, San Clemente, reported that he is a retired paramedic; pointed out that the time to transport patients from San Clemente to Mission Hospital can take 30 minutes.

<u>Pete Curran</u>, San Clemente, former paramedic in San Clemente, spoke in support of bringing a hospital back to the City.

Congratulations to New Council/Expression of Gratitude to City Officers and Staff

<u>Pamela Joy Glass</u>, San Clemente, congratulated the new Councilmembers on their election and expressed gratitude to City representatives who work on behalf of the City.

Public Safety/Condition of Police Substation

Gene James, San Clemente, requested that Council reactivate the Public Safety Task Force for the purpose of enabling it to review the issue of public safety in a holistic manner; voiced concern with the condition of the Police substation.

Ole Hanson Beach Club Weathervane

<u>Larry Culbertson</u>, President of the San Clemente Historical Society, presented a weathervane to the City that is a close replica of the original weathervane that was located above the highest turret at the Ole Hanson Beach Club; thanked Lisa Spinelli for designing the weathervane, San Clemente Woman's Club for funding the materials for the project, and Paul Tierney for providing the machinery skills to create the weathervane.

MOTION BY COUNCILMEMBER WARD to modify the minutes of the City Council Regular Meeting of December 4, 2018 to change her vote on the motion to elect Councilmember Swartz to the office of Mayor from an "Aye" vote to a "Noe" vote to match her nomination that Councilmember Hamm serve as Mayor.

SUBSTITUTE MOTION BY MAYOR PRO TEM BANE, SECOND BY COUNCILMEMBER FERGUSON to direct Staff to view the video of the Council meeting of December 4, 2018 to determine whether Councilmember Ward's vote on the motion to appoint Councilmember Swartz to the office of Mayor was accurately reflected in the minutes.

Following discussion, Council approved the minutes of its December 4, 2018 meeting by consensus, with the understanding that the City Clerk will view the video of the meeting to determine if the vote on the motion to appoint Steve Swartz to the office of Mayor was properly recorded in the minutes. If the minutes are incorrect, they are to be corrected; if the minutes are correct, they are to be finalized as written.

NOTE: Subsequent to the meeting, City Clerk Baade confirmed the accuracy of the minutes as drafted. The minutes were subsequently finalized and entered into the record as originally prepared.

J. Adoption of Policy and Procedure for Guidelines for the Acceptance of Donations, Sponsorships and Gifts and Amendment to Policy and Procedure Relating to Partnership of Activities, Facility Rentals and Special Events

Following discussion, MOTION BY MAYOR SWARTZ, SECOND BY COUNCILMEMBER HAMM, CARRIED 5-0, to:

- 1. Adopt Policy and Procedure No. 204-1 entitled "Partnership of Activities, Facility Rentals and Special Events".
- 2. Adopt Policy and Procedure No. 204-5 entitled "Guidelines for the Acceptance of Donations, Sponsorships and Gifts", with the following modifications:
 - Section 6.2 shall be expanded to read as follows:

"Designated Donations, Sponsors, or Fundraiser Activities may only be accepted when they have a purpose consistent with the City's goals and objectives and are in the best interest of San Clemente. The City must always consider the public trust and comply with all applicable laws when accepting donations. Organizations that qualify for and receive a discount for the use of a City facility through an established Partnership Agreement will not be eligible to receive any fee waiver or subsidy if they accept donations or sponsorships from an organization which is in current litigation with the City."

Section 6.4 shall be modified to read as follows:

"The acceptance of all donations to the City will be based on the following guidelines:

- Purpose of Donation.
- b. Community or municipal need for the Donation.
- c. Compatibility of the Donation with San Clemente Municipal Codes, Policies, and other applicable laws.
- d. Timeliness of the Donation as it relates to implementation.
- e. Level of benefit and financial impact to the City.
- Section 6.5 (which related to Authority to Accept Donations) shall be eliminated.

M. Contract Amendment – Vista Hermosa Sports Park Ballfield Improvements and Acceptance of Donation from San Clemente Little League

Robert Nicolosi, San Clemente Little League, explained that San Clemente Little League has worked with the City and invested nearly \$100,000 to improve City baseball fields; asserted that the fields are not being properly maintained and suggested that the City should retain a fields maintenance company, rather than a landscape company, to maintain the fields.

Following discussion, MOTION BY MAYOR PRO TEM BANE, SECOND BY COUNCILMEMBER FERGUSON, CARRIED 5-0, to:

- 1. Approve, and authorize the City Manager to execute, Amendment No. 1 to Contract C18-40, by and between the City of San Clemente and PSFM. The amendment increases the contract amount from \$1,202,680 to \$1,240,680 (an increase of \$38,000), for supplemental infield work to be completed at the Vista Hermosa Sports Park ballfields #3 and #4.
- 2. Accept a donation of an amount not to exceed \$38,000 from San Clemente Little League to fund the infield improvements to Account 001-000-21563 Wishbook/Park Improvements.
- 3. Direct Staff to agendize the field maintenance contract after baseball season ends for evaluation of the contractor and quality of service.

7. PUBLIC HEARINGS

A. FY 2017-18 Mitigation Fee Act Annual Report

Public Hearing to consider the City of San Clemente Annual Mitigation Fee Act Report for Fiscal Year 2017-18.

Management Analyst Johnston reviewed the contents of the Administrative Report and responded to Council inquiries.

Mayor Swartz opened and closed the Public Hearing, there being no one desiring to speak on this item.

MOTION BY COUNCILMEMBER HAMM, SECOND BY COUNCILMEMBER WARD, CARRIED 5-0, to receive and file the Annual Report concerning the Mitigation Fee Act for Fiscal Year 2017-18, dated December 18, 2018, which is on file with the City Clerk.

B. 2018 Weed Abatement Billing

Public Hearing to consider objections or protests, if any, to the costs of the abatement of weeds, rubbish, refuse and dirt upon streets, sidewalks, parkways and private property within the City of San Clemente and to the assignment of these costs to the properties on which the abatement was completed.

Code Compliance Manager Atamian reviewed the contents of the Administrative Report and responded to Council inquiries.

Mayor Swartz opened and closed the Public Hearing, there being no one desiring to speak on this item.

MOTION BY COUNCILMEMBER HAMM, SECOND BY COUNCILMEMBER WARD, CARRIED 5-0, to:

- 1. Waive the City's notification costs for the compliant property owners.
- 2. Approve the Weed Abatement Report.
- 3. Authorize the Weed Abatement Contract Administrator to bill the amounts indicated in the report to the appropriate property owners.

C. <u>Historic Property Preservation Agreement 18-575, Pekarek Residence – 199 Avenida La Cuesta</u>

Public Hearing to consider approving Historic Property Preservation Agreement 18-575, for the historic house located at 199 Avenida La Cuesta.

Assistant Planner Carrillo narrated a PowerPoint presentation entitled "Historic Property Preservation Agreement 18-575: 199 Avenida La Cuesta (Pekarek Residence)" and responded to Council inquiries. A hard copy of Mr. Carrillo's presentation is on file with the City Clerk.

Mayor Swartz opened the Public Hearing.

<u>Larry Culbertson</u>, San Clemente Historical Society, spoke in support of the proposed Historic Property Preservation Agreement, but voiced concern that Staff is recommending that the property owner be allowed ten years in which to obtain a termite inspection; urged that the timeframes to complete improvements in HPPAs be examined and that shorter completion periods be implemented where appropriate; suggested that Staff should inspect HPPA properties on a more-frequent basis.

There being no others desiring to speak, the Public Hearing was closed.

MOTION BY COUNCILMEMBER HAMM, SECOND BY MAYOR PRO TEM BANE, CARRIED 5-0, to adopt Resolution No. 18-56 entitled A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA, APPROVING HISTORIC PROPERTY PRESERVATION AGREEMENT 18-575 FOR THE PROPERTY LOCATED AT 199 AVENIDA LA CUESTA.

D. <u>Local Coastal Program Land Use Plan Amendment (LUPA) and Authorization to Submit the LUPA to the California Coastal Commission</u>

Public Hearing to consider an amendment to the Certified Local Coastal Program (LCP) Land Use Plan (LUP), that is focused on (1) modifying the threshold year for calculating cumulative changes to an existing structure relative to the "Major Remodel" definition in the LUP and (2) modifying the designation of the two southernmost parcels on Coronado Lane from MU4 (Mixed Use -4) to RH (Residential High) and revising the boundary of the Visitor Serving Commercial District Overlay to exclude these parcels.

Leslea Meyerhoff, Consultant, Summit Environmental Group, Inc., narrated a PowerPoint presentation entitled "City of San Clemente Local Coastal Program Land Use Plan Amendment", and, along with Senior Planner Stiehl, responded to Council inquiries. A hard copy of Ms. Meyerhoff's presentation is on file with the City Clerk.

Mayor Swartz opened the Public Hearing.

Adam Minow, Newport Beach, stated that he is a Certified Public Accountant and is speaking on behalf of his client who is an owner and resident of the Pier Bowl; commended the City's goal to promote visitor-serving land uses in the Pier Bowl area and opined that the inability to use redevelopment funds is one of the reasons that commercial land uses in the Pier Bowl have not proven to be viable or sustainable. A hard copy of Mr. Minow's statement is on file with the City Clerk.

Mandy Sackett, Surfrider Foundation, urged Council to deny the proposed LUPA due to the proposed change to the definition of "Major Remodel".

Mark McGuire, San Clemente, stated that he supports the proposed change in the LUPA that seeks to redefine a major remodel, but urged Council to not pursue the portion of the amendment that relates to redesignating the two southernmost parcels on Coronado Lane from MU4 (Mixed Use-4) to RH (Residential High).

There being no others desiring to speak, the Public Hearing was closed.

(2) Consideration of Nuclear Regulatory Commission letters of November 28, 2018 and November 29, 2018 relating to the results of a routine inspection, as well as a special inspection in response to the misalignment of a loaded spent fuel storage canister at the San Onofre Nuclear Generating Station (SONGS)

Mayor Swartz provided an overview of the Nuclear Regulatory Commission's response to the City's letter concerning an incident involving the misalignment of a loaded spent fuel storage canister at SONGS; voiced concern that the response was not comprehensive and did not identify practices to be used in the future to prevent problems; voiced concern that the City of San Clemente and County of Orange were not immediately informed when the incident occurred; stated that efforts continue with regard to relocating the

nuclear waste from wet storage to dry storage; stated that the Community Engagement Panel continues to seek information from the Nuclear Regulatory Commission and Southern California Edison.

Gene Stone, San Clemente, thanked Mayor Swartz for his participation in the Community Engagement Panel (CEP) and spoke in support of independent real-time radiation monitoring that is accessible to the public.

Sunshine Ordinance

Councilmember Ferguson requested that an agenda report be prepared for the January 15, 2019 City Council meeting concerning the possibility of the City adopting a Sunshine Ordinance; suggested the possibility of establishing an advisory board to review the proposal and prepare a white paper.

During the course of discussion, Council requested that the agenda report include information about the Sunshine Ordinance survey that was provided by BBK and also identify transparency efforts already in effect in the City, e.g., the Transparency portion of the City's website.

Possible Upgrades to Police Facility

Mayor Pro Tem Bane noted that the City expects a budget surplus this year and that the Orange County Sheriffs Department returns overage funds to the City; suggested the possibility of funding common-sense improvements to the Police facility (such as installing lockers, etc.). It was agreed that City Manager Makshanoff will ascertain Police Services' needs.
