It was agreed that Chandler will use proceeds from securities as they mature and gradually implement the new strategy over time. Jason Schmitt from Chandler estimated it would take 6-9 months to implement the new strategy.

City Treasurer, Mark Taylor presented recommended changes to the City's Investment Policy. No motion was sought to approve changes at this time. Investment Policy changes will come back to committee for approval at the next meeting on November 26, 2018.
