REQUEST FOR FEE WAIVER FOR HERITAGE OF SAN CLEMENTE FOUNDATION TO USE

RICHARD T. STEED PARK.

Fiscal Impact: Yes. Loss of field rental revenue totaling \$1,680.

Summary:

Staff recommends that Council approve a fee waiver for the Heritage of San Clemente Foundation. The fee waiver will allow the Heritage Foundation to host a single day

softball tournament for the 2nd Battalion 4th Marines at Richard T. Steed Park.

Background:

The Heritage of San Clemente Foundation is a nonprofit organization that seeks to honor the heroism and commitment of United States Marines by fundraising and supporting donations for Marines stationed out of Camp Pendleton. The Heritage Foundation provides opportunities throughout the year for Marines and their families to honor their efforts by holding barbeques, parades, and toy drives. Additionally, the Heritage Foundation was instrumental in funding the Marine Monument at Park

Semper Fi.

Discussion:

The Heritage Foundation is requesting a fee waiver for field rental fees associated with the use of Richard T. Steed Park for a single day softball tournament for the 2nd Battalion 4th Marines, in an amount not to exceed \$1,680. The softball tournament will be held on Friday, February 15, 2019 and is free of charge for all members of the 2nd Battalion 4th Marines and will also allow for families to enjoy a day at the park. A draft permit detailing the requested use and fee waiver request from the Heritage Foundation are attached.

Response: 100

Conditions of Use: All permit policies, federal, state and local laws enforced. Permit holder has exclusive use of the ball field for the specified time only. No subleasing of fields at any time. No Styrofoam products, amplified sound, or concessions allowed. Do not use metal cleats. The City does not provide storage, goals, bases, equipment, electricity or additional field maintenance (in-field dragging, watering or line placement) beyond routine maintenance. Check san-clemente.org for field closures on the mud line. Parking is available on a first come, first served basis, and will be shared by multiple user groups as well as members of the public. Parking is allowed in designated areas only. User groups must inform their participants and spectators to park in facility lots and public parking areas. It is the user's responsibility to alleviate traffic and parking issues. Penalties for violations include ticketing, towing, revocation of parking privileges Place all trash in appropriate receptacles before leaving the park.

The City requires Commercial General Liability, personal injury and property damage liability, with minimum combined liability limits of One Million Dollars (\$1,000,000) per occurrence. Any deductible or self-insured retention in excess of Five Thousand Dollars (\$5,000) shall be declared to the City and requires the prior approval of the City's Risk Manager. An additional insured endorsement to the general liability policy is required and shall name and list the City of San Clemente, its officials, officers, employees, agents and volunteers as additional insured.

All cancellations and changes must be submitted in writing before any request will be considered. A \$25 processing fee will be charged for cancellations

Synthetic Turf Sports Field Rules and Regulations: Failure to comply with the Synthetic Turf Rules and Regulations will result in cancellation of the reservation. To preserve the quality of the turf and provide a clean and healthy environment, the following are prohibited:

- o Any beverage other than water
- o All food including nuts, seeds, gum
- o Smoking or tobacco products of any kind
- o Glass bottles or containers of any type
- o Dogs and other pets or animals
- o Golfing, javelins, shot putting, discus throwing
- o Metal cleats
- o Grills
- o No individual leg furniture is permitted sled base furniture only
- o Sharp objects such as tent stakes or corner flags
- o Unauthorized vehicles, bicycles, scooters, skateboards
- o Unauthorized marking of lines
- o RC cars, planes or toys that use fuel
- o Lighter fluid or other gasoline type products
- o Dragging of sport equipment. All equipment must be lifted when moved or have turf wheels attached.

Release from Liability and Indemnification: In consideration for and as a condition of the use of the above stated facility, applicant hereby agrees to hold harmless the City, its officers, employees, and agents, against any and all claims, demands, causes of action, damages (including damages to City property), costs and liabilities, directly or proximately resulting from or caused by the use and occupation of the facility hereinabove described, whether such use is authorized or not or from any act of applicant or any of its officers, agents, employees, guests, patrons, or invitees. The applicant shall at its sole risk and expense, defend any and all suits, actions, or legal proceedings which may be brought against the City, its officers and employees in which in any way arise from or relate to applicant's use of the above facility. Applicant shall also pay for any and all damages to any property of City including any damages for loss or theft of such property, done or caused by Applicant, its officers, agents, employees, guests, patrons and invitees.

I have read, understand, and agree to abide by the policies and conditions of use for the facility I am requesting. I will be present at the facility during its use. I further realize the ramifications of failure to abide by the policies and/or permit conditions of use.
