Staff Recommendation

Staff Recommendation

A request to consider modification to an existing restaurant use, including a full range of alcohol for indoor and outdoor consumption, minor exterior modifications to the existing structure, and parking waivers for an increase in indoor and outdoor restaurant seating.

Staff recommends the project be found Categorically Exempt from the California Environmental Quality Act (CEQA) pursuant to State CEQA Guidelines Section 15301 (Class 1: Existing Facilities) and 15303 (Class 3: New Construction or Conversion of Small Structures).
