City Attorney Smith responded that the facts associated with a litigation threat must be disclosed in some circumstances, but not others; stated that it would be an ethical violation for him to elaborate further on the facts and circumstances that justify a briefing in Closed Session; stressed that the Public Records Act does not require the City to disclose its legal vulnerabilities outside of Closed Session.
