# A. Aquatics Partnership Application – San Clemente Aquatics

Carrie Brill, Aquatics Supervisor, summarized the contents of the administrative report regarding an Aquatics Partnership application from San Clemente Aquatics and responded to Commission inquiries.

<u>Goran Westerlund</u>, San Clemente Aquatics Head Coach, responded to Commission inquiries regarding organization finances, salaries, operations, reserve funds, dues, scholarships, and lane use.

Commissioners either individually or in agreement provided the following comments:

- Other organizations with high reserves and coach salaries would not be considered for a subsidy.
- San Clemente Aquatics does not meet the financial need requirement for partnership.
- San Clemente Aquatics has been running a successful program for many years.
- The organization should consider fee reductions for participants, contributions to the City, more scholarships for participants, and/or capital improvement contributions.
- It would be problematic to see organization reserves continue to grow.
- It is difficult to swim in the evening due to pool space used by San Clemente Aquatics.
- The organization could consider increasing fees if needed to cover rental costs.
- The subsidy is large for the number of participants.
- The policy was approved including a three year agreement for Senior Partners.
- Reserves may continue to grow during a three year agreement.
- Junior Partnership should be considered to reduce reserves.
- It is not the goal to reduce allocated lanes.
- A one year Senior Partner agreement with review of financials should be considered.

MOTION BY CHAIR PRO TEM BANDARUK, AND FAILED DUE TO LACK OF SECOND, to recommend the City Council grant Senior Partnership status to San Clemente Aquatics with a three year agreement.

MOTION BY CHAIR STREGER, SECOND BY COMMISSIONER AYER, AND CARRIED 5-0, to recommend the City Council grant Senior Partnership status to San Clemente Aquatics with a one year agreement.
