Subject: *PROPOSED PARKING PROHIBITION ON CAMINO MIRA COSTA.*

Fiscal Impact: None.

Summary: Staff recommends that the City Council approve a parking prohibition on Camino Mira Costa at Camino Capistrano to support operation of the San Clemente Trolley.

Discussion: This summer the San Clemente Trolley will begin service to the northern part of the City, and the City Council approved the new route which includes a new trolley stop on Camino Mira Costa just east of the intersection with Camino Capistrano. To provide a dedicated space to allow trolley vehicles to pick up and drop off passengers, staff recommends prohibiting parking on the southeast side of Camino Mira Costa for a distance of 60 feet from the intersection (refer to location map in Attachment 1). While this would eliminate parking for about three vehicles, parking demand in this area is very light and vehicles are rarely parked on this segment of Camino Mira Costa. Also, there are no residential properties with driveway access along the entire Camino Mira Costa frontage. Therefore, the proposed new parking restriction will not adversely impact parking in this area. On April 12, staff mailed a notice to all properties within 300 feet of the proposed location to inform nearby property owners of the proposed parking prohibition. As of April 19, staff had not received any comments.

Recommended

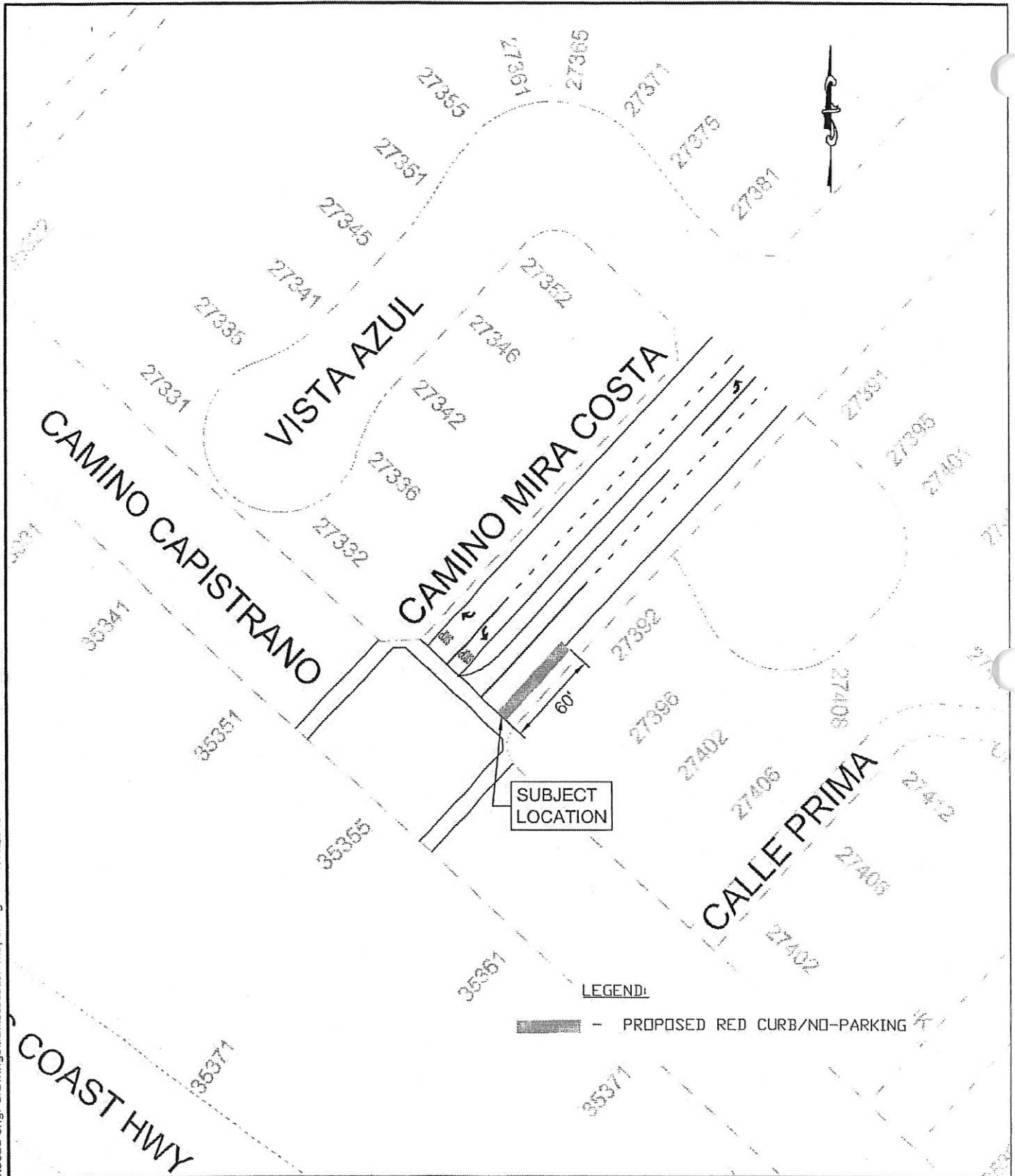
Action: STAFF RECOMMENDS THAT the City Council:

1. Prohibit parking on the south side Camino Mira Costa from Camino Capistrano to 60 feet east of Camino Capistrano; and
2. Adopt Resolution No. _____, entitled "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA, AMENDING MASTER TRAFFIC RESOLUTION NO. 1846, ESTABLISHING A 'NO PARKING AREA' ON CAMINO MIRA COSTA."

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
SAN CLEMENTE, CALIFORNIA, AMENDING MASTER
TRAFFIC RESOLUTION NO. 1846, ESTABLISHING A 'NO
PARKING AREA' ON CAMINO MIRA COSTA

WHEREAS, the City reviews various locations to improve safety and traffic conditions; and

WHEREAS, the San Clemente Trolley will begin service in late May 2019 to northern San Clemente, including service on Camino Mira Costa; and

WHEREAS, the City Council previously approved the trolley route to serve northern San Clemente, including a trolley stop on Camino Mira Costa just east of the intersection with Camino Capistrano; and

WHEREAS, staff has recommend the proposed parking prohibition below to facilitate establishment of a trolley stop to provide a space for trolley vehicles to pick up and drop off passengers; and

WHEREAS, the City Council has considered the recommendation and information provided by City staff and now wishes to implement the recommended parking prohibition.

NOW, THEREFORE, The City Council of the City of San Clemente does hereby resolve as follows:

Section 1. The above recitals are true and correct.

Section 2. The Master Traffic Resolution No. 1846, Section 23, entitled "No Parking Areas", is hereby amended by adding subsection:

23.d-4b Camino Mira Costa, southeast side, from Camino Capistrano to sixty (60) feet east of Camino Capistrano.

Section 3. The City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.
